It is informed as under: -

- 1) In exercise of the powers conferred by section 84 of the Right of Persons with Disabilities Act, 2016 (Central Act 49 of 2016), the Governor of Haryana, after concurrence of the Chief Justice of the Punjab and Haryana High Court vide notification no. S.O.66/C.A.49/2016/S.84/2018 dated 09.10.2018 specified the court of 2<sup>nd</sup> Additional Sessions Judge, and if there is only one court of Additional Sessions Judge, then Additional Judge in each district to be a Special Court to try offences, under the said Act. 
