The Government of Haryana has notified the Model Online Transfer Policy, 2026 vide Notification No. 99-2026/Ext dated 25 June, 2026.

2. Clause 2(iv) of the Model Online Transfer Policy, 2026 provides that the Human Resources Department, with the prior approval of the Hon'ble Chief Minister, shall maintain and publish the list of cadres across Departments to which the Policy shall apply and shall also specify, in respect of each such cadre, the applicable Unit(s), Minimum Tenure and Prescribed Tenure.

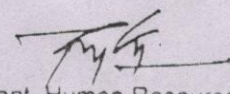

Accordingly, in exercise of the powers conferred under Clause 2(iv) of the Model Online Transfer Policy, 2026, and after due consideration of the administrative framework envisaged under the said Policy, the Human Resources Department has finalized the list of cadres pertaining to your Department to be covered under the Policy, together with the corresponding Unit(s), Minimum Tenure and Prescribed Tenure, as specified in **Annexure-A**.

4. The parameters specified in **Annexure-A** have been determined keeping in view the cadres covered under the previous online transfer framework and have been standardized by the Human Resources Department with the objective of ensuring transparency, uniformity and parity across Departments, having regard to the nature of duties, level and category of posts, sensitivity of assignments and other relevant considerations.

5. The enclosed list shall form the basis for implementation of the Model Online Transfer Policy, 2026 in respect of your Department. Any proposal for revision of the cadres covered under the Policy or the corresponding Unit(s), Minimum Tenure or Prescribed Tenure shall be dealt with strictly in accordance with Clause 2(iv) of the Model Online Transfer Policy, 2026.

6. The above may kindly be noted for strict compliance and further necessary action may be taken in accordance with the provisions of the Model Online Transfer Policy, 2026.

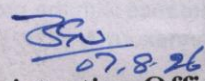
