Whereas Mukesh Malik approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No. 25423 of 2019 – Mukesh Malik V/s State of Haryana & others praying therein for the issuance of a writ in the nature of Certiorari quashing the impugned transfer order dated 06.09.2019 (Annexure P-4) passed by the respondent No. 2 vide which the petitioner has been transferred from Government High School, Garhi Sisana (3668), Block Kharkhoda, District Sonapat to Government Girls Middle School, Sultanpur Nuh (6541), Block Nagina, District Nuh, Mewat in utter violation of the guidelines/instruction of the Govt. Haryana issued vide Circular dated 26.09.1986 (Annexure P-6) and Transfer Policy, 2016 dated 05.06.2017 (Annexure P-5) as well as against the basic principal of natural justice. Further directing the respondent No. 2 to reconsider and cancel the impugned transfer of the petitioner in the light of guidelines/instruction of the Govt. Haryana issued vide Circular dated 26.09.1986 (Annexure P-6) and Transfer Policy, 2016 dated 05.06.2017 (Annexure P-5).

That the above-mentioned case was fixed for hearing on 11.09.2019 and on this date, this Hon'ble High Court was pleased to pass following orders: -

***“Inter alia contends that petitioner never opted for change of cadre on the basis of transfer policy and was relieved on 06.09.2019 much less threatened also. As per the guidelines, he was also protected under the list of Head Masters. Moreover, petitioner's wife is already working in the rest of Haryana as Government Lecturer in Government College, Rohtak.***

***Notice of motion for 20.09.2019.***

***On asking of Court, Mr. R.K.Doon AAG, Haryana, who is present in Court, accepts notice on behalf of the respondents/State and seeks time to file reply. Let requisite number of copies of paper book be supplied to learned State Counsel during course of day, if not supplied earlier.***

***It has also been contended that objections qua transfer policy have already been uploaded on the portal. The pendency of writ petition would not prevent the respondents to take decision on the representation in accordance with law and decision taken thereon shall be communicated to the petitioner or produced in Court on the adjourned date.***

***Liberty is granted to make mention.”***

Thereafter, the petitioner filed a CM application vide No. 13720-CWP of 2019 in CWP 25423 of 2019. The said CM came up for hearing before the Hon'ble High Court on 17.09.2019 and on this date, this Hon'ble High Court was pleased to pass following orders: -

**“Learned State counsel seeks short accommodation.**

**Learned counsel for the petitioner has pointed out that petitioner has already given up his fore-going promotion.**

**Adjourned to 20.09.2019.**

**In the meantime, operation of relieving orders qua petitioner shall remain stayed and he shall be allowed to continue at the same station from where he was relieved.”**

In compliance of direction of the Hon'ble Court, transfer of petitioner has been stayed and currently he is working at same school i.e. Government High School Garhi Sisana (3668), Sonipat [Zone 5] from where he was relieved. The copy of stay order dated 19.09.2019 is annexed herewith for kind perusal.

It is worthwhile to mention here that the petitioner is misleading the Hon'ble High Court by stated that the petitioner has given up his forgoing promotion. At present, the petitioner is working as Elementary School Head Master. No forgo order has been issued by the answering respondent till today.

Thereafter, the case of petitioner has been examined carefully and it has been found that the petitioner was initially appointed as Math Master vide order dated 31.12.2002 and joined at Government Senior Secondary School Kathura, Sonipat (3680) [Zone-3] in the respondent department and remained there upto 02.09.2008, that thereafter, petitioner was transferred to Government High School Gijhi (2775) [Zone 5], and joined there on 03.09.2008 and worked there upto 07.09.2017. That thereafter, petitioner was transferred to Government High School Garhi Sisana (3668), Sonipat [Zone 5] and joined there on 08.09.2017 and worked there upto 06.09.2019. After that the petitioner was promoted as Elementary School Head Master from TGT Mathematics and posted at Government Girls Middle School, Sultanpur, Nuh Mewat (6541) [Zone 5] in Transfer Drive on 06.09.2019. It is also pertinent to mentioned here that the answering department had opened a grievance drive for aggrieved employees on 15.09.2019 but the petitioner did not participate in the said grievance drive. It is also pertinent to mentioned here that the petitioner was

promoted as Elementary School Head Master vide order No. 15/32-2019 HRM-III (1) dated 24.08.2019 with condition to participate in upcoming transfer drive for promotional station. The copy of promotion order dated 24.08.2019 is annexed herewith for kind perusal.

Thereafter, the petitioner had filed the said petition claiming the issuance of direction to the answering respondent to adjust the petitioner in the previous school in District Sonapat. It is pertinent to mention here that the petitioner was promoted as Elementary School Head Master vide order No. 15/32-2019 HRM-III (1) dated 24.08.2019 with condition to participate in upcoming Transfer Drive for promotional station. The petitioner participated in the online system of adjustment and was posted at anywhere category as an Elementary School Head Master after promotion on 24.08.2019. The said Transfer Drive was opened on 06.09.2019 for all the employees who complete their MIS profile as per direction of the department. The petitioner had participated in Transfer Drive and opted more than 156 options/preferences in Transfer Drive on 06.09.2019. The petitioner had got 46.811 points on MIS portal. It is pertinent to mentioned here that the petitioner was transferred to Government Girls High School Hassanpur Taoru, Nuh Mewat (711) [Zone 5] according to his points on MIS portal. It is also relevant to submit that the petitioner has also wrongly construed the order dated 06.09.2019 as transfer order whereas it is a promotional adjustment order. As per Transfer Policy, 2016 the answering respondent has transferred the employees anywhere in the State and anywhere in the District. The Sub-clause (i) of clause 3 of Teacher Transfer Policy, 2016 as under:

**(i) Teachers who are members of State Cadre or District Cadre are liable to be transferred anywhere in the State and anywhere in the District, as the case may be, at any point of time.**

It is also relevant to submit that the petitioner has admitted this fact that his service is governed by the Haryana School Education (Group-C) State Cadre Service Rules, 2012 but he failed to consider Rule-12 of the Service Rules, 2012 before approaching this Hon'ble High Court. A kind consideration of Rule-12 would reveal itself that the employee/TGT/ESHM concerned is liable to serve at any place within or outside Haryana on being ordered so to do. The petitioner had concealed this fact that the post of ESHM/TGT rationalized from Govt. Senior Secondary Schools and he has been adjusted in adjoining district- Nuh. However, the operative Rule-12 is reproduced herein;

**"12. Liability to serve:**

**(1) A member of the Service shall be liable to serve at any place, whether within or outside the State of Haryana, on being ordered so to do by the appointing authority.**

**(2) A member of Service appointed by direct recruitment on contract basis shall be liable to serve for a continuous period of five years in the rural area from the date of appointment.**

**A member of Service appointed by promotion or by transfer shall be liable to serve for a continuous period of three years in the rural area from the date of such appointment. If not already served for a period of fifteen years in the rural area.**

**A member of the Service may also be deputed to serve under,- a company, an association or a body of individuals whether incorporated or not, which is wholly or substantially owned or controlled by the State Government,**

**a municipal corporation or a local authority or university within the State of Haryana; the Central Government or a Company, an association or a body of individuals, whether incorporated or not, which is wholly or substantially owned or controlled by the Central Government; or**


**any other State Government, an international organization, an autonomous body not controlled by the Government, or a private body:**

**Provided that no member of the Service shall be deputed to serve the Central or any other State Government or any organization or body referred to clause (ii) or clause (iii) except with his consent.**

Keeping in view the controversy involved in the present writ petition i.e. the husband and wife should be posted at the same station as far as possible. In this context, it is pertinent to mention here that when the instruction dated 26.09.1986 was issued by the Government of Haryana, there was no such online policy qua the transfer of teacher in the State of Haryana. The said instruction was applicable on the offline transfer, to bring the fairness and equality, the State of Haryana brought online transfer policy for teacher transfer in the year 2016. It is specifically mentioned in Teacher Transfer Policy, 2016 dated 05.06.2017 (amended as on 01.06.2017) that the 2016 policy shall be applicable w.e.f. academic session 2016-17. On the perusal of such online policy, it is evident that the State of Haryana has taken care of each and every aspect of teachers and accordingly provides the provision of point system for such requirement. There is specific provision of 5 points for female teacher in couple case. However, as such there is no provision for the male teacher and such a decision has been taken by State of Haryana in its wisdom after having regard to the facts and circumstances. To sum up, instruction dated 26.09.1986 is not applicable in online transfer norms and also there is no provision of extra points to male teacher in couple case.

Besides above, the case of petitioner has been examined by the competent authority and it has been found that the petitioner has wrongly construed the order dated 06.09.2019 as transfer order whereas it is a promotional adjustment order. Therefore, in view of the above background and factual position of the case, the claim of the petitioner is fulfilled/gratified.
