



Whereas Pushpa Devi approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No. 1870/2020 – Pushpa Devi Vs. State of Haryana & Others praying therein inter alia for issuance of a writ in the nature of mandamus directing the respondents to promote the Petitioner to the post of TGT Physical Education

The said petition came up for hearing on dated 24.01.2020 before the Hon'ble High Court on 24.01.2020 and was disposed off with the following directions:-

[1] Prayer in the writ petition is for the issuance of a writ of mandamus for directing the respondents to promote the Petitioner to the post of TGT Physical Education.

[2] Learned counsel states that the Sender fulfills all conditions entitling him for promotion to the post of TGT Physical Education but the claim has not been considered and decided despite legal notice (Annexure P-4) dated 11.09.2018 having been served on the respondents and that in the circumstances, the Petitioner would be satisfied, if the writ petition is disposed of by directing respondent No.2 to consider and decide the claim made in the legal notice (Annexure P-4) dated 11.09.2018, in accordance with law in a time bound manner.

[3] Notice of motion to respondent No.2 only.

[4] Mr. Harish Rathee, learned Senior Deputy Advocate General, Haryana, accepts notice on behalf of respondent No.2 and states that he has no objection to the limited prayer made by learned counsel for the Sender.

[5] Without commenting upon the merits of the claim or the entitlement of the petitioner to the relief claimed, the writ petition is disposed of by directing respondent No.2 to consider and decide the claim made in the legal notice

(Annexure P-4) dated 11.09.2018, in accordance with law, after taking into account all aspects of the matter, as expeditiously as possible, preferably within a period of 03 months from the date of receipt of certified copy of the order.

In compliance of abovementioned order dated 24.01.2020 of the Hon'ble High Court, the legal notice sent by the Advocate of Smt. Pushpa Devi dated 11.09.2018 has been examined. As per report received from District Elementary Education Officer (DEEO) Bhiwani it is found that Smt. Pushpa Devi had taken admission in regular course of B.P.Ed (Bachelor of Physical Education) during the period from 2010 to 2011 but appropriate Earned Leave had not been availed by her for this course. Further, it was found that she had availed Earned Leave from 20.01.2011 to 15.05.2011 which was only for the examination purpose.

In order to give fair and proper opportunity, it was decided by the Competent Authority to provide personal hearing to her on 09.11.2020. Accordingly, Smt. Pushpa Devi appeared before the Competent Authority. During the personal hearing, her grievance was heard at length and she has given four names of similar situated teachers, namely, Naresh Kumari (009011), Shiv Kumar (061588), Vishnu Dutt (060794) and Naresh Kala (05993). According to her the above , mentioned Employees/teachers were similar situated and they had been promoted on the post of Demonstrator in Physical Education (DPE). After look into her grievances, Department enquired about these four employees and found that such four cases are not identical with her. Two of them i.e. Shiv Kumar (061588), Vishnu Dutt (060794) acquired all the requisite eligibility criteria before joining the services which were required for the promotion on the post of Demonstrator in Physical Education (DPE). In case of Naresh Kumari though acquired the degree of B.P.ED during the course of service but such college was 20 kms away from the place of her earlier posting and in case Smt. Naresh Kumari got promotion in wrong manner then such promotion order would be scrutinize in the due course and will take step accordingly. In case of Naresh Kala, it is important to note that he had filed Civil Writ Petition vie CWP No. 33079 of 2018 wherein he prayed for the promotion on the post of Demonstrator in

Sh, n

Physical Education (DPE). In such writ petition, Department had already filed the reply and matter is pending before the Hon'ble High Court.

Coming now to the facts of the present case, while scrutinized her documents it has been found as mentioned above that Smt. Pushpa Devi had passed degree of B.P.Ed (Bachelor of Physical Education) during the job without taking sufficient leaves as to obtain this degree that was regular course and moreover it was done from the Rashtrasant Tukadoji Maharaj Nagpur University, hence, it was not possible for her to pursue the degree course simultaneously with the Job. Hence, Department needs to inspect from the concerned University about the authenticity of the B.P.ED degree before taking the final decision on her promotion case. Hence her case will be considered immediately after confirmation received from the University.

In view of above factual matrix and record of the case, promotion claim of Smt. Pushpa Devi cannot be considered at this stage without verification of the authenticity of the B.P.ED degree from the concerned University. Needless to say that once the authenticity of the degree stands verified from the concerned university, Smt. Pushpa Devi would also be entitled to seek promotion as per the provisions of law. Hence, the claim of the Smt. Pushpa Devi is declined/rejected at this stage.

I pass Order accordingly.


