उपरोक्त विषय पर भारत सरकार से प्राप्त पत्र क्रमांक 1-5/2002 डेस्क एम0डी0एम१ दिनांक 9.10.2002 प्रति संलग्न के संदर्भ में।
भारत सरकार से प्राप्त परिपत्र पैरा 2 के 11 में निम्नलिखित हिदायत जारी की गई है।

States where food grains are distributed by authorities other than the PDS outlets, such as, School authorities, Panchayats, etc. they may be allowed to dispose of the bags through auction on a monthly bases. The Central Govt. may not prescribed any rate or fix the price of the empty Gunny bags because of the condition of Gunny bags in the local area. However, the PTAs/VECs or such other School Forms may be involved in the auction process and also for maintenance of accounts.

Subject: Disposal of Empty Gunny Bags under Mid day Meal Scheme.

Sir,

Under Mid day meal (NP-NSPE) food grains are supplied free of cost to the implementing agencies as per allocation made by this Ministry. The cost of food grains including cost of gunny bags is reimbursed by this Ministry to the FCI.

2. In its Review Report (Report 3 year ending March 2000) on National Programme of Nutritional Support to Primary Education (Mid day Meal Scheme), the Comptroller & Auditor General of India pointed out that there were no clear instructions from Government of India regarding disposal of empty gunny bags in States/UTs. Accordingly with the concurrence of Financial Adviser (IRD) and the chief Controller of Accounts (IRD) in this Ministry, the following has been decided with regards to disposal of gunny bags.

(a) States/UTs which are serving Mid day Meal may utilize the proceeds on the purchase of items necessary for implementation of the program. For instance, the items required for preparation of a meal such as oil, condiments, fuel etc.

(b) States/UTs where food grains are being distributed the following procedure may be adopted.

(i) States where food grains are distributed through PDS out lets, the empty gunny bags may be allowed to be retained by the Fair Price Shop owner as per the provisions of the PDS

(ii) States where food grains are distributed by authorities other than the PDS outlets, such as, school authorities, Panchayats, etc. they may be allowed to dispose of the bags

through auction on a monthly basis. The Central Government may not prescribe any rate or fix the price of the empty gunny bags because of the condition of gunny bags in the local area. However, the PTASV Asst. Secy. in each other school forms may be involved in the auction process and also for maintenance of accounts.

The procedure laid down Para at 2 (b) (i) and 2 (b) (ii) above is purely temporary subject to the outcome of Writ Petition No. 196/2001 filed by People's Union of Civil Liberty against Union of India and others in Hon'ble Supreme Court of India.

3. It is requested that necessary instruction may please be issued accordingly to the implementing agencies under intimation to this Ministry.
