Whereas a representation as well as a legal notice dated 18.08.2020 as got served by Sh. Jawahar Lal, ESHM (ID-071742), Govt. Middle School, Ishargarh (2363), Block-Thanesar (Kurukshetra) have been got submitted/served upon this Directorate to have promotion on post of Elementary School Head Master (i.e. ESHM) w.e.f. 13.06.2013, the undersigned having competency of Appointing Authority under Rule-6 of Service Rules 2012, has observed that the present representationist(s) as well as Sh. Jawahar Lal have been kept deprived (aggrieved) from having claimed promotion w.e.f. 13.06.2013. They acknowledged their entitlement to have promotion to post of ESHM in advance. Even having got served directions dated 01.03.2013 and 25.04.2013 from the Hon'ble High Court in CWP No. 4301/2013, this Directorate failed to take proper steps as per statutory service rules 2012 well in time, the reasons thereof have not been disclosed.

Since every action of the State or its instrumentalities should not only be fair, legitimate and above-board but should be without any affection or aversion. It should neither be suggestive of discrimination nor even give an impression of bias, favouritism and nepotism. Procedural fairness is an implied mandatory requirement to protect against arbitrary action where Statute confers wide power coupled with wide discretion on an authority. If the procedure adopted by an authority offends the fundamental fairness or established ethos or shocks the conscience, the order stands vitiated. It is also a settled principle of law that the wrongdoer cannot take advantage of its own wrong. A man should not be permitted to take undue and unfair advantage of his own wrong to gain favour-able interpretation of law.

After due consideration of submitted factual position in light of statutory Service Rules 2012, the present representationist(s) & Sh. Jawahar Lal, (i.e. ESHMs of Order No. 17/178-2016 HRM-II (2) dated 01.12.2016), have remained successful to establish their locus standi to have benefit of promotion (ESHM) w.e.f. 13.06.2013. Even so, they are allowed the benefit of promotion w.e.f. 13.06.2013 notionally (as they performed no duty of ESHM) and actually w.e.f. date; they joined service on post of ESHM. All other similarly situated senior Sanskrit Teachers, having educational qualifications of B.A. & B.Ed., e.g. Order No. 17/58-2018 HRM-II (2) dated 07.03.2019 be also granted identical benefits to avoid further litigation in present matter. Consequential benefits of pay fixation as well as seniority as per Rule-11 of applicable Service Rules 2012 be granted to all such entitled Sanskrit Teachers, now ESHM immediately.
