Whereas, the present civil writ petition No. 26354 of 2017 titled as Roshan Lal & Others Vs. State of Haryana. was filed by the petitioners praying therein for issuance of an appropriate order or direction, calling for the record of the cases and directing the respondents to promote the petitioners on the post of ESHM w.e.f. 04.09.2017 i.e. from the date their junior (Private respondents) have been promoted vide order dated 04.09.2017 (Annexure P-9) and grant them all consequential benefits including the seniority, pay and arrears of pay with market rate of interest.

The said petition was disposed of by the Hon'ble High Court on dated 18.02.2020 and the Hon'ble High Court passed the following order in which the interim part is as under:

*"Instant writ petition was filed in the year 2017 seeking a mandamus directing the official respondents to promote the petitioners to the post of Elementary School Head Masters w.e.f. 04.09.2017 i.e. the date their juniors i.e. private respondents No.4 to 49 have been so promoted. All consequential benefits have also been prayed for.*

*In para 2 of the writ petition, the service particulars of the petitioners in the nature of date of appointment as JBT, date of promotion/ joining as Sanskrit Teacher as also educational qualifications have been furnished. Furthermore, in para 8 of the writ petition, the details of the seniority numbers of the petitioners and the private respondents as per seniority list as C&V Teachers have been furnished to demonstrate that juniors have been granted the benefit of promotion while denying such benefit to the petitioners. There are also categoric averments in the petition that as per Haryana School Education (Group 'C') State Cadre Service Rules, 2012, all the petitioners are eligible to be considered for promotion.*

*Instant writ petition was came up for preliminary hearing on 20.11.2017. Notice of motion was issued for 29.11.2017 and State counsel had accepted the notice in Court and had been furnished a complete copy of the writ petition.*

*Inspite of a period of more than 26 months having elapsed, written response is not forthcoming.*

*Mr. Kiran Pal Singh, learned AAG, Haryana upon instructions from Ms. Renu Arya, Legal Assistant, Education Department, Haryana informs the Court that case of the petitioners for promotion to the post of Elementary School Head Masters w.e.f. 04.09.2017 is under active consideration. He furnishes an assurance that subject to eligibility, promotion orders would be issued in favour of the petitioners w.e.f. the date their juniors were so promoted within a period of 2 months from today. Statement made by learned State counsel is accepted.*

*No further directions are required to be passed.*

*Writ petition is disposed of.*

*Pending application(s), if any. shall also stand disposed of".*

That after receiving the said court direction from the Hon'ble High Court, the matter of the petitioners has been examined carefully and the cases of petitioners have been called from concerned DEEO. The case of the petitioners was sent to committee for checking the eligibility of 1 to 12 petitioners. The committee submitted the report and out of 12 petitioners 9 petitioners were found eligible i.e. 1 to 4 and 7 to 11 who are working as Sanskrit Teacher as per Haryana Service Rules (Group-C) 2012 as well as NCTE norms. The petitioner No.5 and 6 are not eligible being working as SS Master and Math Master


respectively not as Sanskrit Teacher. The petitioner No.12 is not found eligible due to less mark to 50% in B.A. i.e. 47.66%.

Keeping in view of position explained above, the petitioner No. 1, 2, 3, 4, 7, 8, 9, 10 and 11 have been promoted vide 17/37-2018 HRM-III (1) dated 01.10.2019. It is pertinent to mention here that the promotion case of TGTs has been considered upto seniority No. 4500 for general category and upto seniority 7900 for reserve category by the Directorate. The promotion cases of TGT/Master cadre are considered upto seniority No. 4500 for general category on the basis of seniority-cum-merit basis of the respective employees whereas the seniority of the petitioner No. 5 and 6 is beyond the seniority No. 4500.

Besides above, the cases of petitioner No. 5 and 6 have been examined by the competent authority. It has been found that, the promotion case of the petitioner will be considered on their turn as per the respective seniority of the petitioner in TGT Cadre. On the other hand, the petitioner No. 12 is not found eligible due to not having 50% marks in B.A. as per the provision of Rules, 2012.

Keeping in view the matter explained above, the petitioner No. 1, 2, 3, 4, 7, 8, 9, 10 and 11 has been promoted vide 17/37-2018 HRM-III (1) dated 01.10.2019 and the petitioner No. 5, 6 and 12 cannot be promoted as Elementary School Head Master and claim of petitioner 5, 6 and 12 are rejected in above terms and in compliance of Hon'ble Court direction.
