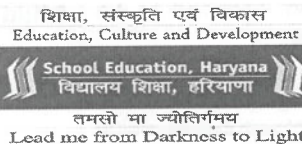



3. As stated by Sh. Balraj Singh these sale deeds were registered after the school time. In others he has taken Casual Leave without prior sanction from the competent authority.
4. For the sale purchase of these properties no permission was taken from the higher authorities. No employee was handed over the school charge before leaving the station for registry purpose.
5. Out of 21 occasions of Registry 3 days (14.06.2012, 10.01.2012 and 13.06.2013) falls in vacations; on 12.12.2011 he was present in SSA Camp and on 5 days attendance has been marked in register (03.05.2012, 23.02.2012, 29.11.2012, 21.11.2013 and 07.12.2015). At 9 occasions (20.12.2011, 03.01.2012, 29.05.2012, 17.05.2012, 20.09.2012, 15.12.2015, 21.02.2012, 24.04.2012 and 29.11.2011) there is overwriting in the attendance register.

He replied the charge sheet on 10.02.2020/12.02.2020 and refused the charges leveled upon him with the request to file the charge sheet.

On finding the reply unsatisfactory, Sh. R.P. Bhasin, District and Session Judge (Retd.) was appointed as Inquiry Officer to conduct the regular department inquiry against the delinquent vide Order No.14/64-2018 HRM-III (2) dated 10.06.2020. The Inquiry Officer conducted the departmental enquiry and submitted its report dated 04.08.2020 in which as per finding of the Inquiry Officer, the charges stand proved against the delinquent.
