You nameiy, Ajay Kumar, TGT (English), GSSS Partap Nagar (Yamuna Nagar) has committed the following violations of statutory conduct rules and showed an irresponsible behaviour which has been found as omission of statutory obligations or commission of mis-conduct by an employee:

While making comments on Mid-Day-Meal Order dated 20.03.2020 regarding disbursing of Food-Grains Packets and Cooking Costs among eligible School Children as issued by this Directorate, you nameiy, Ajay Kumar, TGT (English), GSSS Partap Nagar (Yamuna Nagar) has committed the following violations of statutory conduct rules, mis-conducts and showed an irresponsible behaviour:

1. That it is well known to you that Mid-Day-Meal Scheme is run by Union of India. The Union of India has already framed a policy 2015 for those circumstances in which cooked meal is not supplied to eligible schools' students still you acted in irresponsible and negligent manner;
2. That you have no authority to get clarification of a departmental letter or order/direction from a private Counsel or Advocate and got its interpretation uploaded on social media without consulting the same with higher authorities;
3. That you have admitted this fact that vide the interim order dated 18.03.2020 of the Hon'ble Supreme Court of India has directed the Union of India and all State/U.T. Governments to provide Mid-Day-Meal facility to all eligible school children getting education up to Upper Primary Level, you made irresponsible statements on Social Media by way of up-loading a video against this Directorate Order dated 20.03.2020 wherein the above-said interim order has been complied with;
4. That even not having responsibility of Mid-Day-Meal Incharge of school i.e. GSSS Partap Nagar (Yamuna Nagar), you opposed the Directorate order dated 20.03.2020 and instigated the teachers not to comply with the same;
5. That in your statement in above-said, you have quoted that the Directorate has issued this letter dated 20.03.2020 without considering the danger of COVID 19 and called this order as "Mohammad Tuglaq's order";
6. That you are not a spokesman of Elementary Education Department or its employees in District-Yamuna Nagar, still you have made statement on social media against Directorate Order dated 20.03.2020 and instigated the teachers against the said order and tried to create a propaganda against Govt. of Haryana and its Directorate;
7. That the Food-Grains packets were supposed to be served by staff deputed by DEEO whose duty was to ensure safety standards while distributing food grains. still you knowingly created hindrances

List/Statement of Charges/allegations and its process against Sh. Ajay Kumar, TGT (English), Govt. Girls Senior Secondary School, Partap Nagar (Yamuna Nagar).

You namely, Ajay Kumar, TGT (English), GSSS Partap Nagar (Yamuna Nagar) has committed the following violations of statutory conduct rules and showed an irresponsible behaviour which has been found as omission of statutory obligations or commission of mis-conduct by an employee:

While making comments on Mid-Day-Meal Order dated 20.03.2020 regarding disbursing of Food-Grains Packets and Cooking Costs among eligible School Children as issued by this Directorate, you namely, Ajay Kumar, TGT (English), GSSS Partap Nagar (Yamuna Nagar) has committed the following violations of statutory conduct rules, mis-conducts and showed an irresponsible behaviour:

1. That it is well known to you that Mid-Day-Meal Scheme is run by Union of India. The Union of India has already framed a policy 2015 for those circumstances in which cooked meal is not supplied to eligible schools' students still you acted in irresponsible and negligent manner;
2. That you have no authority to get clarification of a departmental letter or order/direction from a private Counsel or Advocate and got its interpretation uploaded on social media without consulting the same with higher authorities;
3. That you have admitted this fact that vide the interim order dated 18.03.2020 of the Hon'ble Supreme Court of India has directed the Union of India and all State/U.T. 4. That even not having responsibility of Mid-Day-Meal Incharge of school i.e. GSSS Partap Nagar (Yamuna Nagar), you opposed the Directorate order dated 20.03.2020 and instigated the teachers not to comply with the same;
5. That in your statement in above-said, you have quoted that the Directorate has issued this letter dated 20.03.2020 without considering the danger of COVID 19 and called this order as "Mohammad Tuglaq's order";
6. That you are not a spokesman of Elementary Education Department or its employees in District-Yamuna Nagar, still you have made statement on social media against Directorate Order dated 20.03.2020 and instigated the teachers against the said order and tried to create a propaganda against Govt. of Haryana and its Directorate;
7. That the Food-Grains packets is supposed to be served by the Cook cum helper in supervision of Mid-Day Meal Incharge whose duty was to ensure safety standards while distributing food grains, still you knowingly created hindrances in getting disbursed the food-grains packets to eligible children;
8. That without considering gravity of the Hon'ble Supreme Court order dated 18.03.2020 and the Mid-Day Meal Policy, 2015 as suggested by the Union of India through letter dated 20.03.2020, you disobeyed all the said
