#### **ORDER**

Order No. 17/77-2020 HRM-I(3)

Dated :- 18.12.2020

Sh. Hira Lal Rohilla and others had filed CWP No. 632 OF 2020 titled as Hira Lal Rohilla and Others versus State of Haryana, which was decided on 13.01.2020 and the Hon'ble High Court was pleased to pass the following order dated 13.01.2020 which is reproduced as under:-

"Petitioners are seeking direction to the respondents to refix their pay in the upgraded pay scale of Rs.6500-10500 w.e.f. 01.01.1996 in view of provisions of Haryana Civil Services (Revised Pay) Rules, 2008 with further prayer of granting 1st, 2nd and 3rd ACP grade pay to them from due dates on completion of 10, 20 and 30 years of regular service.

The petitioners are working as Teachers on regular basis in the Education Department, Haryana and some of the petitioners have retired after 01.01.2006. The petitioners have made a legal notice dated 21.08.2019 (Annexure P-5).

Learned counsel for the petitioners is relying upon judgment passed by this Court having similar issue in CWP-25868-2018 Chander Bhan Sharma and others V/s. State of Haryana and others, which was disposed of on 08.10.2018.

Issue notice of motion.

On asking of the Court, Mr. Kiran Pal Singh, AAG, Haryana accepts notice on behalf of the respondent-State.

Without commenting upon merits of the case, this petition at this stage is being disposed of by giving direction to respondent No. 2 to decide the legal notice dated 21.08.2019 (Annexure P-5), within a period of six months from the date of receipt of certified copy of this order. The respondent No. 2 shall pass a speaking order thereon after affording

opportunity of hearing to the petitioners, failing which, respondent No. 2, shall be liable to pay cost of Rs.50,000/- each to the petitioners.

This condition of imposing cost is only to prevent the petitioners to run from pillar to post and avail remedy of contempt in case of non-compliance of directions issued by this Court."

In compliance of the above order dated 13.01.2020, legal notice dated 21.08.2019 (Annexure P-5) has been perused and considered by the undersigned and an opportunity of personal hearing had been given to the claimants/petitioners as on dated 15.09.2020. However, only Petitioner No. 56 Sh. Narayan Singh, Math Master GHS, Sadhrana, Gurgaon had appeared at the time of hearing who was heard but the other Petitioners namely, Petitioner No. 37 Sh. Dharamvir, retired SS Master GGSSS, Gurawara, Rewari and Petitioner No. 38 Sh. Hari Kishan SS Master GGSSS, Gurawara, Rewari and Petitioner No. 42 Sh. Sher Singh retired SS Master GSSS, Lula Hir, Rewari and Petitioner No. 89 Smt. Saroj Bala Science Mistress GSSS Katar Puri, Gurgaon were absent and not appeared for hearing and inadvertantly the Petitioner No. 94 Smt. Prabha Sharma SS Mistress GSSS Gurgaon Village was not conveyed message and she was directed to appear for personal hearing on dated 10.11.2020. All the claimants sought the benefits of modified/upgraded pay scale w.e.f. 01.01.1996 in the terms of provisions of Haryana Civil Services Revised Pay Rule 2008 and notification dated 20.08.2009.



It is pertinent to mention here that on the recommendation of the 5<sup>th</sup> Central Pay Commission, the Finance Department to Government Haryana revised the pay scale of its employees including teachers w.e.f. 01.01.1996 as per the Haryana Civil Services Revised Pay Rules 1998. As

per these rules the pay scale of the post of JBT/PTI/Drawing teachers were revised from Rs. 1200-2040 to Rs. 4500-7000. With a view to remove stagnation on account of non promotion of the employees for certain years of service, the Government Haryana had decided to grant 1<sup>st</sup> and 2<sup>nd</sup> ACP scales to its employees on completion of 10 & 20 years of regular satisfactory services as per Haryana Civil Services (ACP rules), 1998.

Whereas the pay scale of Master, Sanskrit/Hindi teachers were revised from Rs. 1400-2600 to Rs. 5500-9000 w.e.f. 01.01.1996. So they have been allowed 1<sup>st</sup> ACP scale of Rs. 6500-9900 and 2<sup>nd</sup> ACP of Rs. 6500-10500 on completion of 10 & 20 years of regular satisfactory service as per Haryana Civil Services (ACP rules), 1998.

Further on the recommendation of the 6<sup>th</sup> Central Pay Commission, the Finance Department to Government of Haryana further revised the pay scale of its employees including teachers w.e.f. 01.01.2006 by framing Haryana Civil Service (revised pay) Rules, 2008 as per notification dated 30.12.2008. As per these rules, the pay scale of the post of JBT Teachers were revised in pay band of Rs. 9300-34800 with grade pay of Rs. 4200/- w.e.f. 01.01.2006.

As mentioned in the foregoing paras, the pay scale has been revised on 01.01.2006 as Rs. 4500-7000. Revised pay structure w.e.f. 01.01.2006 is Rs. 9300-34800-PB-2 GP-3600. It is pertinent to mention here that vide notification dated 20.08.2009, the Government of Haryana further modified pre revised pay structure as Rs.9300-34800-PB-2 GP-4200 in case of PTI teachers, Art & Craft(Drawing teacher) and Cutting and tailoring teachers. In case of JBT Teacher as per HCS (Revised Pay) Rules, 2008 the grade pay was already been modified as Rs. 4200. It is

the

clear from pay structure only the grade pay was modified as Rs. 4200 under the HCS (Revised Pay) Rules, 2008 and notification dated 20.08.2009. But the pay scale/pay band was the same as Rs.9300-34800-PB-2.

In case of petitioner No. 37 namely Sh. Dharamvir, two ACPs have already been granted to him. He was appointed as SS Master on 01.01.1979 regularly and his pay scale has been fixed Rs. 6500-9900 w.e.f. 01.04.1999 and 2nd ACP was granted on 01.01.2000 and He retired on the scale 6500-10500 as per his eligibility and entitlement.

In case of Petitioner No. 38 namely Sh. Hari Krishan, He was appointed as JBT Teacher on 18.07.1995 and promoted as SS Master on 19.07.2005 in the scale of 5500-9000.

In case of Petitioner No. 42 namely Sh. Sher Singh, He was appointed as SS Master on 01.01.1979 and 2<sup>nd</sup> ACP was granted on 31.03.2000 in the scale 6500-10500 and he has retired on 31.07.2007.

In case of Petitioner No. 56 namely Sh. Narayan Singh, He was appointed on 01.10.2003 as Math Master and 1<sup>st</sup> ACP was granted on 01.10.2013 and 2<sup>nd</sup> ACP was granted on 01.10.2019. It is relevant to mention here that the petitioner is not eligible for benefit under Haryana Government notification on 07.02.2019 for the refixation of the pay in the modified/upgraded pay scale of Rs. 6500-10500 w.e.f. 01.01.1996.

In case of Petitioner No. 89 namely Smt. Saroj Bala and she was appointed as JBT on 12.07.1995 and she was promoted as Science Mistress on 14.10.1999 and 2<sup>nd</sup> ACP has granted on 01.11.2009 and 3<sup>rd</sup> ACP has granted on 01.11.2015. It is relevant to mention here that the



petitioner is not eligible for benefit under Haryana Government notification on 07.02.2019 for the refixation of the pay in the modified/upgraded pay scale of Rs. 6500-10500 w.e.f. 01.01.1996.

In case of Petitioner No. 94 namely Smt. Prabha Sharma, she

was appointed as JBT on 01.02.1992 and she was promoted as SS

Mistress as on 10.11.1999 and 2<sup>nd</sup> ACP was granted on 01.12.2009 and

she was retired as on 30.06.2013. It is relevant to mention here that the

petitioner is not eligible for benefit under Haryana Government notification

on 07.02.2019 for the refixation of the pay in the modified/upgraded pay

scale of Rs. 6500-10500 w.e.f. 01.01.1996.

Keeping in view the above explained facts as well as after

discussion with the concerned dealing Assistants who had been posted in

the office of DEEO Rewari and Gurugram, who are present in the office of

the undersigned as on dated 15.09.2020 alongwith the relevant record of

the abovesaid petitioners, it is clear that all the benefits regarding their pay

fixation and the ACPs have already been granted under the HCS (Revised

Pay) Rules, 1998 and 2008 and nothing is due or pending with the

department. So, I reject their cases regarding the required benefits.
