Whereas Ramesh Kumar 51 others, which include TGTs, C&V teachers, Head Teachers and PRTs approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. **CWP No. 8258 of 2016- Ramesh Kumar & others versus State of Haryana & others** praying therein for issuance of a writ in nature of certiorari to get quashed the impugned condition in Finance Department Haryana order dated 04.03.2014 (Annexure P-3) whereby the benefit of length of regular satisfactory service for granting benefit of 1st /2nd /3rd Assured Career Progression (i.e. ACP) scales has been modified from 10/20/30 years (as defined in the Haryana Civil Services (ACP) Rules 2008) to 08/16/24 years but this order having reduced length of regular satisfactory service for granting ACP Benefits has been made effective prospectively i.e. with effect from 04.03.2014 instead of 01.01.2006 and arrears of ACP benefits from 01.01.2006 to 04.03.2014 have been denied. The petitioners have further prayed for issuance of a writ in the nature of mandamus directing the respondents to implement this order dated 04.03.2014 w.e.f. 01.01.2006 i.e. the date whereby the Haryana Civil Services (ACP) Rules 2008 have been made operative.

This Civil Writ Petition came up for hearing before the Hon'ble High Court on 18.03.2017 and the Hon'ble Court pleased to dispose of this writ petition in following order:

"For orders, see judgment passed in CWP No. 17496 of 2014 titled Om Parkash and others Vs. State of Haryana and others of even date."

Having such directions, the judgment passed in CWP No. 17496 of 2014- Om Parkash & others versus State of Haryana & others has been pursued. After due perusal of this judgment dated 18.03.2017, it has been observed that the Hon'ble High Court has already declined the present claim of petitioners by way of clarifying that the Finance Department Haryana order dated 04.03.2014 cannot be considered as a substitution of the Haryana Civil Services (ACP) Rules 2008 and it is operative prospectively. The operative extract of judgment dated 18.03.2017 is defined herein for ready reference as under:

"8. Crux of the matter is whether the benefit of order dated 4.3.2014 arising out of ACP Rules, 2008 could be extended to those who have retired prior to 4.3.2014 and to those who are in service as on 4.3.2014 or not. The order dated 4.3.2014 vide Annexure P-3 while invoking under Rule 26 and 28 of the Haryana Civil Services (Assured Career Progression) Rules, 2008 dated 30.12.2008 is not applicable to such of those retired employees who have retired prior to 4.3.2014 for the reasons that having regard to the applicability of Clause Rule 2 of the Haryana Civil Services (Assured Career Progression) Rules, 2008 cited supra is concerned is not applicable to the retired employees. Therefore, whatever the rules made under Haryana Civil



Service (Assured Career Progression) Rules, 2008 read with the order dated 4.3.2014 is not applicable to those who have retired from service. Accordingly, insofar as petitioners who have retired from service prior to 4.3.2014, the present petition stands dismissed.

9. Learned counsel for the petitioners those who have retired from service relied on decision of this Court passed in LPA No.352 of 2014 (State of Punjab and others Vs. A.P. Sharma and others) has considered the effect of retroactive. Therefore, in terms of the said decision even for the retired employees are entitled for benefit of ACP from retrospective date. Perusal of the facts of the case in LPA read with the present matter, it is entirely different. There the question is relating to pension whereas in the present case relates to ACP when the ACP Rules, 2008 is very specific to the extent of application of ACP Rules, 2008 those who are in service and not for the retired employees. Therefore, the cited decision by the petitioners counsel is distinguishable. The same is not applicable to the retired persons like petitioners in this bunch of petitions.

10. The persons who are in service prior to 4.3.2014, the benefit of order dated 4.3.2014 is applicable to the extent that grant of ACP to those who have completed 8, 16 and 24 years of service, the same cannot be denied prospectively i.e. after 4.3.2014. Having regard to the fact that 4.3.2014 order is not substitution to the 2008 Rules as is evident from the fact that on 4.3.2014 certain modified ACP Grade pay in respect of category I and II was incorrect. In order to rectify the same, the official respondents have proceeded to pass a fresh order on 4.3.2014 with reference to cited note (supra). In that context the word "(to be substituted bearing with same number and date)" has been indicated. In other words it does not mean that substitution of the 2008 Rules. It is only substitution of 4.3.2014 order to the extent of rectifying the category 1 and 2 and modified ACP Grade Pay from 10650-10800-2000 (1st 2nd and 3rd ACP) to 1800-1900-2000 (1st, 2nd and 3rd ACP), respectively. In view of these factual and legal aspects the petitioners are not entitled for any benefit retrospectively. In other words intervening period from 1.1.2006 to 4.3.2014 is applicable to only those who are in service as on 4.3.2014 and not for those who have retired from service prior to 4.3.2014."

Now in compliance of Hon'ble High Court order dated 18.03.2017, the claim of petitioners for granting of Assured Career Progression Scales as defined in Annexure P-1 has been examined. After due perusal of contents of Annexure P-1, it has been observed that all the petitioners have already been granted the benefit of ACP scales on completion of requisite regular satisfactory service of 10/20/30 years prior to 04.03.2014. In para-2 of



writ petition, it has been admitted that some of the petitioners have already been retired from service; therefore, the cause of action for all the petitioners is not an identical one. It has also been observed that the petitioners have kept their date of retirement concealed to have undue ACP Scales' benefit. The principle "who seeks equity must come with clean hands" can easily be made applicable in present scenario.

In view of position defined/explained above, it is evident itself from interpretation of letter by the Hon'ble High Court that the Finance Department Haryana Order dated 04.03.2014 cannot be made applicable retrospectively on retired TGTs/C&V teachers/HTs or PRTs.

Besides the above, it is relevant to state further that the petitioner who is in service on 04.03.2014 and who has completed the requisite length of regular satisfactory service, if not already availed benefit of Finance Department Order dated 04.03.2014, may approach the competent appropriate authority by way of submitting a representation defining therein true facts of his/her regular satisfactory service.

Moreover, the petitioners have defined in Annexure P-1 that they have already availed the benefit of ACP scales as per applicable financial rules, therefore, in view of above-said factual position, no claim for granting ACP scales w.e.f. 01.01.2006 on completion of 08/16/24 year's regular satisfactory service is made out. The present claim of petitioners is found devoid of merits, therefore, the same is, hereby, declined.

Order accordingly.
