- 2 इसके द्वारा श्री सोनू निमल, विज्ञान अध्यापक, रा0मा0वि0 खातीवास, जिला महेन्द्रगढ से उनके द्वारा इस ज्ञापन की प्राप्ति की तिथि से 45 दिन की अवधि के अन्दर लिखित रूप में बताने की अपेक्षा की जाती है कि वे सभी आरोपों या उनमें से किसी को स्वीकार करती/करता है या नहीं। उन्होंने क्या स्पष्टीकरण या प्रतिवेदन, यदि कोई हो, प्रस्तुत करना हैं और क्या वे व्यक्तिगत रूप में अपनी सुनवाई चाहता है।
- 3 इसके द्वारा श्री सोनू निमल, विज्ञान अध्यापक, रा0मा0वि0 खातीवास, जिला महेन्द्रगढ को आगे सूचित किया जाता है कि वे अपने लिखित कथन को तैयार करने के प्रयोजन के लिये सुसंगत सरकारी अभिलेखों को देखना चाहता है तो उन्हें निदेशक मौलिक शिक्षा हरियाणा पंचकूला के कार्यालय में उनके साथ पहले समय नियत करने के बाद, किसी कार्य दिवस को, उनका निरीक्षण करना चाहिए। फिर भी यह बताया जाता है कि उन्हें केवल ऐसे ही दस्तावेज दिखाये जायेंगे, जोकि निदेशक मौलिक शिक्षा हरियाणा पंचकूला के पास है और जो मामलों के साथ पूरी तरह से सुसंगत है, यदि सरकार की राय में उन्हें किन्ही दस्तावेजों को दिखाने की अनुमति देना लोकहित में वांछनीय नहीं है, तो उन्हें वह दस्तावेज दिखाने के लिए इन्कार कर दिया जायेगा। यदि श्री सोनू निमल, विज्ञान अध्यापक ऐसे किसी अन्य सुसंगत अभिलेख को देखना चाहता है जो निदेशक मौलिक शिक्षा हरियाणा पंचकूला की अभिरक्षा में नहीं है तो उनका निरीक्षण करने की जिम्मेदारी उनकी अपनी है, फिर भी श्री सोनू निमल, विज्ञान अध्यापक को यह बात स्पष्ट की जाती है कि उनके द्वारा उक्त दस्तावेज का निरीक्षण न किया जा सकना उनके लिखित कथन को भेजने में देरी के लिए वैध आधार नहीं माना जायेगा और यदि लिखित कथन निम्नहस्ताक्षरकर्ता को निर्दिष्ट अवधि के अन्दर प्राप्त नहीं होता तो यह समझा जायेगा कि उन्हें कुछ भी प्रस्तुत नहीं करना है।

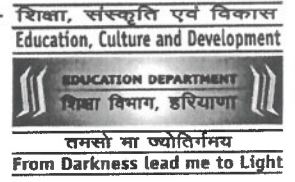

Dated, Panchkula the 18.6.2021

Whereas Sh. Yoginder Singh and 35 others approached the Hon'ble Punjab & Haryana High Court at Chandigarh by way of filing a Civil Writ Petition i.e. 18940 of 1995- Yoginder Singh & Others V/s State of Haryana & Others, praying therein for issuance of a writ in the nature of Mandamus, Certiorari or any other suitable writ directing the respondents to grant them the benefit of higher pay on acquiring of higher qualification of B.A. in accordance with the Full Bench Judgment of this Hon'ble High Court in CWP No. 484 of 1986 titled as Om Parkash Arya vs State of Haryana etc. which has been upheld by the Hon'ble Supreme Court of India on 19.10.1994.

The writ petition came for hearing before the Hon'ble Court on 15.05.2018 wherein the Hon'ble Court was pleased to dispose of the writ petition in accordance to the judgment passed by the Hon'ble Supreme Court of India in State of Haryana & others V/s Hem Lata & others, cited as (2010) 2 SCC 369, as under:-

"Heard.

It is not disputed that the present matter is covered by the decision of the Supreme Court in State of Haryana & others Vs. Hem Lata Gupta & others, (2010) 2 SCC 369. As per Hem Lata Gupta's case, those Teachers, who had acquired higher qualifications in terms of Government policy dated 20.06.1977, after appointment and in service, they would have a right to the benefit of advance increment. The instructions dated 20.06.1977 were

d

withdrawn on 20.12.1982, but the accrued benefits following to the share of the petitioners before the withdrawal of the policy would have to be disbursed to them.

Consequently, the instant petition is disposed of with a direction to the respondents to process the case of the petitioners in accordance with law and release benefits as per policy then prevailing within and do so within a period of three months from the date of receiving of a certified copy of this order, in case the benefit has not already been sanctioned and disbursed."

Having directions dated 15.05.2018, the field offices have been directed to ensure the date of appointment as well as date of passing M.A. as higher qualification, After having such information defined in Annexure P-I of the writ petition, the bio- data of all petitioners is reproduced as under:-

After due consideration and record received from concerned DEEOs, it has been observed that out of total 36 petitioners, Petitioner No. 1, 13, 15, 17, 18, 19, 28, 29, 30, 32 and 33 are Social studies Masters, Petitioner No. 16 Head Teacher, Petitioner No. 2, 3, 5, 6, 7, 11, 12, 14, 22, 23, 24, 25, 26, 31 and 34 are rendering service on post of JBT Teacher, Petitioner No. 4, 8, 9 and 10 are Hindi Teacher, Petitioner No. 20 Drawing teacher and Petitioner No. 36 retired lecturer and where the minimum requisite qualification for post is Post Graduation (M.A or M.Sc/M.Com) hence these petitioners are totally out of consideration of this benefit. In case of other petitioners the contents of Circular No. 4718-2GS-II-77/17173 dated 20.06.1977 are very crucial to be discussed here as under:-

Personal pay shall be granted to all employees, who improve their qualifications after joining Govt. Service, if the qualification (s) so acquired from a recognized University is/are higher than the minimum qualifications prescribed for the post on which they were recruited at the time of entry into Govt. service, in accordance with the scales and conditions laid down in the succeeding paragraphs/ sub-paragraphs:-

(i) Personal pay admissible for acquiring each of the following qualifications shall be equal to the amount of increments(s) mentioned against each qualifications:-

- (a) Diploma of at least one year's duration one increment
- (b) Law degree of the post graduate two increments
- (c) Doctorate or Post Doctorate qualifications four increments

Provided that the maximum benefit will not exceed the equivalent of four increments.

(ii) Govt. employees who have acquired the aforesaid qualifications after 26.09.1972 (i.e. whose result as declared on or after the said date) shall be eligible for the benefit of personal pay with effect from the date of declaration of the result of the examination concerned and those who had improved their educational qualifications before 26.09.1972 (i.e. whose result was declared before the said date) shall be eligible for the benefit of personal pay with effect from the date of issue of these instructions. In either of the two types of cases, thereto of increment for the purpose of calculating the amount of personal pay shall be taken to be that which was last drawn prior to the date of eligibility.

(iii) ***No benefit shall be given for such of these qualifications as had already been acquired by the Govt. employee before joining Govt. service.***

(iv) ***This benefit shall not be admissible to adhoc employees.***

(v) ***If say, a graduate Govt. servant is appointed to another post for which the minimum qualifications is post-graduation and he subsequently acquires a post graduate degree, he shall not be***

entitled to this benefit of personal pay. This principle will be applicable to all such cases.

- (vi) According to the present instructions graduate Clerks/Stenotypist/Junior Scale Stenographers are entitle to benefit of two advance increment with from 01.02.1969. The amount of these advance increments will not be taken into account while computing the personal pay according to (i) above.
- (vii) A Committee of the Administrative Secretary and the Head of the Department concerned shall be formed for deciding cases under this scheme. This committee shall consider the question of granting personal pay to a Govt. employee and decide to grant it provided that at least half the annual reports earned during the five years preceding the date of eligibility where at least average. In case of record of an employee does not justify grant of personal pay from the date of eligible personal pay will be given to him with effect from a subsequent date when the aforesaid criterion of record is fulfilled.
- (viii) The benefit of personal pay shall be extinguished after five year from the date from which it is granted.
- (ix) ***This benefit will be available to a Govt. employee only once during his entire service. For example, if a person had availed himself of this benefit on the basis of his having acquired a post-graduate degree, he cannot claim the benefit again if he acquires a law degree later.***
- (x) This benefit of personal pay will not be available to Class-I Officers. However, if a Class-II officer acquires such a qualifications and becomes eligible for the grant of personal pay, this benefit will cease on his becoming a Class-I officer.

The matter has been considered in accordance to judgment passed by the Hon'ble Supreme Court of India in Smt. Hem Lata's case (supra) on the basis of the reports as received from the O/o District Elementary Education Officers Section Officers from the dated 13.12.2019 (DEEO Nuh), 22.06.2020 (DEEO Narnaul), 14.01.2020 (DEEO Karnal), 24.01.2020 (DEEO Panchkula), 14.01.2020 (DEEO Kurukshetra); and none of petitioners has been found entitled to have benefit of advance increment on acquiring higher qualifications in accordance to order dated 20.06.1977 (ibid). Besides this fact, it is also relevant to state that the benefit of higher pay scales (JST) is not applicable in case of Masters, Lecturers and Headmasters. Moreover, these instructions have also been withdrawn by the Education Department, Govt. of Haryana vide order dated 09.03.1990. On the basis of above rules all the petitioner's benefit is to be rejected individually.

Considering the claim of the petitioners in accordance to Smt. Hem Lata's judgment, no one is found entitled as they have not acquired the higher qualification during substantive service period it may either be acquired during adhoc/six months/daily wages period or prior to joining service on regular basis which is not to be counted in accordance to order dated 20.06.1977. Hence, the claim of the petitioners is found devoid of merits; accordingly, the same cannot be accepted/ granted.
