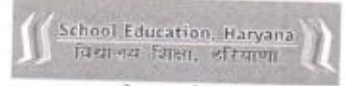

Order No. 17/66-2020 HRM-III/ESHM (1)

Dated Panchkula the, 05.08.2021

Whereas, the present COCP No. 1323 of 2021 titled as Harpal Singh & Another V/s Anshaj Singh, IAS in civil writ petition No. 21777 of 2020-Harpal Singh & Another V/s State of Haryana & Others was filed by the petitioners praying therein for directing the Respondent No.2 to promote the petitioners to the post of ESHM in HES-III (School Cadre) from the date person junior to the petitioners were promoted as such vide order dated 01.12.2016 and 04.09.2017 (Annexure P-6 and P-7) respectively, issued by the respondent No. 2 by ignoring the claim of the petitioners in most illegal, arbitrary and discriminatory manner. Further prayed to grant all the consequential benefits, including the arrears of pay with statutory interest for which the petitioner legally entitled.

The said petition came up for hearing before the Hon'ble High Court on 17.12.2020 and the following order was passed.

"The grievance of the petitioners is that they are not being promoted with effect from the date their juniors were promoted. Even representations dated 15.05.2020 (Annexure P-10) and 26.05.2020 (Annexure P-11) have not been responded to.

Notice of motion.

Mr. Sanjay Mittal, Addl. A.G. Haryana, accepts notice on behalf of the respondents and waives service.

Considering the nature of the order being passed there is no necessity of filing a written statement.

The petition is disposed of with a direction to respondent No. 2 to decide the pending representations dated 15.05.2020 (Annexure P-10) and 26.05.2020 (Annexure P-11) in accordance with rule and law and pass a speaking order thereupon within a period of eight weeks from the date of receipt of certified copy of this order."

The present contempt petition came up for hearing before the Hon'ble High Court on 09.07.2021 and the following order was passed :-

"Case is being taken up for hearing through Video Conferencing due to Covid-19 pandemic.

Issue notice to the respondent to show cause as to why proceedings under the Contempt of Courts Act, 1971 be not initiated against him.

Mr. Sandeep Singh Mann, learned Addl. AG, Haryana, accepts notice on behalf of the respondent and requests for two weeks' time to submit compliance report as well as reply.

Adjourned to 10.08.2021."

That, after receiving the said court direction from the Hon'ble High Court, the matter of the claimants has been examined carefully and it has been found that there are total 2 claimants in the present writ petition. Both the claimants are having B.A. & B.Ed.


In the compliance of direction issued by the Hon'ble High Court, the representation dated 15.05.2020 (Annexure P-10) and 26.05.2020 (Annexure P-11) has been examined and it has been found that initially the claimant No. 1 i.e. Sh. Harpal Singh (Seniority No.794) was appointed as Sanskrit Teacher and regular vide order No E-2-97/2223-24 dated 13.10.1997. He passed B.A. with 51.71% in 19.06.1988 from MDU, Rohtak and B.Ed. on 13.09.1990 from MDU, Rohtak. The claimant No. 2 i.e. Sh. Shri Pal Kumar (Seniority

15.01.2019. It is also worthwhile to mention here that the claimant No. 1 is at Seniority No. 794 whereas the claimant No. 2 is at Seniority No.1949. After examining the cases of both claimants it has been found that claimant No.1 i.e. Sh. Harpal Singh is eligible for promotion as per his seniority and available vacancy with the department. On the other hand, the claimant No.2 i.e. Shri Pal Kumar is not eligible for promotion at present as per his seniority and as no vacancy is available.

In the view of above, the promotion cases of Sanskrit teacher on the post of Elementary School Head Master are being called upto the Seniority No.1200 as per Seniority list dated 15.01.2019. A Show Cause Notice for reversion shall be issued to those employees who were promoted on the basis of date of appointment and who are not falling in the seniority list dated 15.01.2019 upto seniority No. 1200. After considering the promotion cases on basis requisite qualification as per Service Rule, 2012, further as per the seniority in the seniority list dated 15.01.2019 and vacant seats available. The promotion of the eligible Sanskrit Teacher will be done within one month from the date of this order.

Keeping in view the matter explained above, the claimant No.1 will be promoted as Elementary School Head Master and the claimant No.2 will be considered at his turn as per his seniority in seniority list dated 15.01.2019. Therefore, within one month, claimant No. 1 as is eligible and fall at seniority No. 794 will be promoted as per vacancy with all the other employees eligible for promotion whose promotion cases are being called up within one month. On the basis of present circumstances, the claim of the claimant No.2 has been rejected as per his respective seniority in the seniority list dated 15.01.2019 in above terms.

I order accordingly.
