Subject:- Reply to the legal notice/demand notice.

On the subject cited above, it is submitted that the applicants served a legal notice-cum-demand notice for participating in Transfer Drive as her representation to transfer from GSSS, Jakholi Adda (Kaithal) to GGSSS Balbehra (Kaithal) is considered by the Department.

It is pertinent to mention here that as per the file no. 6/83-2019 HRM-1(3) dated 20.12.2019 it is processed according to the order of Hon'ble CM on the subject. It is submitted that a committee was constituted at the district level to recommend the cases of deputation/ transfer cases at the district level proposal regarding temporarily transfer/ deputation of teacher as per Memo No. KW15/123-2019 CO-II(5) dated 19.12.2019 but nothing could be received about the representationist by the respondent department. Thereafter, a letter dated 30.06.2020 alongwith photocopy of recommendation by District Level Committee by Reference No- E-2/19/1769 dated 30.12.2019.

Therefore, her case from GGSSS Jakholi Adda (Kaithal) to GGSSS Balbehra (Kaithal) of Smt. Sushma Sharma vide Order No. 6/10-2020 HRM-1(3) dated 01.07.2020 has submitted to decide the transfer matter on the basis of

Medical and has returned back on dated 24.08.2020 in pursuance of the orders of the CM with submission that according to dated 31.07.2020, the cases related to transfer/deputation will not be considered due to open of transfer drive.


It is worthwhile to mention here that vide Order No. 4/33-2011SE(4) dated 14.08.2019, related to PGT, the district in which the number of posts in a particular subject is less than 300, the transfer of those teachers will not be considered in the General transfers.

It is worthwhile to mention here that vide Order No. 3/71-2019CO(3) dated 25.08.2019, related to ESHM, TGT, C&V, HT and JBT teachers, the district in which the number of posts in a particular subject (Music, Home Science and Urdu) is less than 300, the transfer of those teachers will not be considered in the General transfers.

It is pertinent to mention here that new instructions dated 18.11.2020 Chief Secretary, Haryana Government has received in which a submission of updation and implementation (Online Transfer Policy) has been made that the district in which the number of posts in a particular subject is 300 or more than 300. However, after careful consideration it has been decided by the Government instructions No. 15/5/2017-1GS-II dated 23.06.2021, Chief Secretary, Haryana Government that online transfer policy shall be made applicable for the posts having cadre strength of 80 or more.

Thus, the case of the representationist can be considered in the online General transfer drive and for their transfers it will be considered online.
