- (i) School registration and display of vacancies for the year 2021-22 by recognised private schools on the school registration portal, notice board and school website from **9th October, 2021 to 17th October, 2021.**
- (ii) Publication of advertisement for admission in recognised private school for EWS and BPL category on **14th October, 2021.**
- (iii) Publication of District and Block Level Committees on **14th October, 2021.**
- (iv) School Verification by BEO/BEEOs & DEO/DEEOs from **18th October, 2021 to 22nd October, 2021.**
- (v) Date of receipt of online student applications from **24th October, 2021 to 7th November, 2021.**
- (vi) Publication of list of eligible applicants by BEO/BEEOs & DEO/DEEOs on **11th November, 2021.**
- (vii) Assessment examination to be held on **14th November, 2021.**
- (viii) Declaration of result on **19th November, 2021.**
- (ix) First draw of lots at the State Level on **24th November, 2021.**
- (x) Admission on the basis of 1st draw of lots from **26th November, 2021 to 8th December, 2021.**

- (xi) Second draw of lots for remaining seats, if applicable will be announced later.

It must be ensured that the above instructions are complied with in letter and spirit by the private schools.


