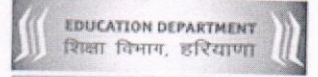

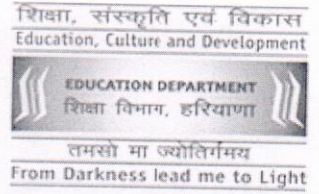



Order No. 17/66-2020 HRM-III/ESHM (1) DATED, PANCHKULA, THE 12.10.2021

In the compliance of direction issued by the Hon'ble High Court dated 17.12.2020 in CWP No. 21777 of 2020 titled as Harpal Singh & Another V/s State of Haryana & Others, the following Sanskrit Teacher who has the requisite qualification of Elementary School Head Master is hereby provisionally promoted against the post of Elementary School Head Master in HES-III (School Category) with effect from 01.12.2016 and 04.09.2017 from which his juniors were promoted. However, he is entitled seniority and notional pay fixation. No arrears will be paid to him for this promotion.

Note : However, he is directing to participate in the upcoming transfer drive for his regular posting.

The above promotion is subject to the following terms and conditions:-


1. That this promotion will be subject to review/cancellation, in case of any discrepancy regarding seniority/eligibility is found as well as subject to the condition that no prejudice to the right of senior, if any, whose promotion case may be decided at later stage on the basis of amendment of Rules by adding the following entry in the existing Rules i.e. "Shastri with at least 50% marks from a recognized university and Shiksha Shastri/Language Teachers Course (L.T.C.)/Oriental Training (O.T.) in Sanskrit conducted by the Haryana Government or an equivalent qualification recognized by Haryana Education Department."
2. That this promotion order will be subject to review/cancellation on the basis of above amendment if right of any senior prejudice as per the seniority list dated 15.01.2019.
3. That this promotion is subject to the condition that no adverse remarks against integrity are found in his unavailable ACRs later on mentioned against his name.
4. That his seniority in the Elementary School Head Master will be determined later on as per Service Rules and instructions issued from time to time by the Govt./Department.
5. That this official should fulfill the conditions of educational qualifications/ experience as per the service rules. In case it transpires at a later stage that they are ineligible for the above promotion, the department would be competent to revert the concerned official to his original post without any notice.

Order No. 17/66-2020 HRM-III/ESHM (1)

Dated Panchkula the, 12-10-21

Whereas, the present COCP No. 1323 of 2021 titled as Harpal Singh & Another V/s Anshaj Singh, IAS in civil writ petition No. 21777 of 2020-Harpal Singh & Another V/s State of Haryana & Others was filed by the petitioners praying therein for directing the Respondent No.2 to promote the petitioners to the post of ESHM in HES-III (School Cadre) from the date person junior to the petitioners were promoted as such vide order dated 01.12.2016 and 04.09.2017 (Annexure P-6 and P-7) respectively, issued by the respondent No. 2 by ignoring the claim of the petitioners in most illegal, arbitrary and discriminatory manner.

The said petition was came up for hearing before the Hon'ble High Court on 17.12.2020 and the operative part is as under:-

"The petition is disposed of with a direction to respondent No. 2 to decide the pending representations dated 15.05.2020 (Annexure P-10) and 26.05.2020 (Annexure P-11) in accordance with rule and law and pass a speaking order thereupon within a period of eight weeks from the date of receipt of certified copy of this order."

The present contempt petition was came up for hearing before the Hon'ble High Court on 09.07.2021 and the following order was passed :-

"Case is being taken up for hearing through Video Conferencing due to Covid-19 pandemic.

Issue notice to the respondent to show cause as to why proceedings under the Contempt of Courts Act, 1971 be not initiated against him.

Mr. Sandeep Singh Mann, learned Addl. AG, Haryana, accepts notice on behalf of the respondent and requests for two weeks' time to submit compliance report as well as reply.

Adjourned to 10.08.2021."

That, after receiving the said court direction from the Hon'ble High Court, the matter of the Claimants has been examined carefully and it has been found that there are total 2 Claimants in the present writ petition. Both the Claimants are having B.A. & B.Ed.

In the compliance of direction issued by the Hon'ble High Court, the representation dated 15.05.2020 (Annexure P-10) and 26.05.2020 (Annexure P-11) has been examined and it has been found that initially the Claimant No. 1 (Seniority No.794) was appointed as Sanskrit Teacher and regular vide order No E-2-97/2223-24 dated 13.10.1997. He passed B.A. in 19.06.1988 from MDU, Rohtak and B.Ed. on 13.09.1990 from MDU, Rohtak. The Claimant No. 2 (Seniority No.1949) was appointed as Sanskrit Teacher and regular vide dated 22.03.2002. He passed B.A. in 02.12.1987 from MDU, Rohtak and B.Ed. on 05.09.1989 from MDU, Rohtak.

It is pertinent to mention here that as per Haryana Civil Services Rules, 2012, Appendix-B (Rule-7) the qualification for the promotion to the post of ESHM is as under :

It is pertinent to mention here that prior the seniority list of C&V Sanskrit teachers dated 15.01.2019, the promotion case of Sanskrit Teachers on the post of Elementary School Head Master were considered on the basis of date of appointment of Sanskrit teachers. Thereafter, the seniority list for promotion on the post of ESHM from the C&V Sanskrit teacher has been made on 15.01.2019. The cases of both the Claimants have been examined as per their respective seniority in seniority list dated 15.01.2019. It is also worthwhile to mention here that the Claimant No. 1 is at Seniority No. 794 whereas the Claimant No. 2 is at Seniority No.1949. After examining the cases of both Claimants it has been found that Claimant No.1 is eligible for promotion as per his seniority and available vacancy with the department. On the other hand, the Claimant No.2 is not considered for promotion at present as per his seniority and available vacancy.

In the view of above, the promotion of the Claimant No.1 i.e. Sh. Harpal Singh has been done vide order No. 17/66-2020 HRM-III/ESHM (1) dated 12.10.2021 and Show Cause Notice for reversion shall be issued to the juniors of the Claimant No.2 after completion of formalities who are working as Elementary School Head Master. The

promotion case of Claimant No.2 shall be considered as per his turn on the basis of seniority-cum-merit as per Service Rules, 2012.

Keeping in view the matter explained above, the claim of the Claimant No.1 has been considered by promoting him as Elementary School Head Master whereas the claim of Claimant No.2 has been rejected as per their respective seniority in the seniority list dated 15.01.2019 and availability of vacancy in above terms.
