Terms of reference of DECs is to meet periodically at District Headquarters at least once in three months to review and coordinate the overall development of power supply infrastructure in the district in accordance with the schemes of the Government which may, inter alia include the following aspects:-

- All Government of India Schemes including their progress and quality issues.
- ii) Development of Sub-transmission and distribution network including regular operations and maintenance of network identifying further areas where strengthening is needed.
- iii) Impact of the works on quality and reliability of power supply.
- iv) Standards of Performance and consumer services/quality of supply.
- v) Complaints and Grievance Redressal System.
- vi) Any other relevant matter.
