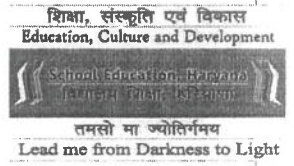

ORDER

Order No. 17/99-2016 HRM-II (3)

Dated Panchkula, the 15.12.2021

Whereas under Punjab Education Service (School Cadre) Rules, 1955, Primary Teachers/ JBTs were entitled to be promoted to the post of DPE. The said rules were replaced by new service rules, Haryana State Education Cadre (Group-C) Services Rules, 1998 which came into existence with effect from 12.05.1998. As per the Service Rules 1998, a Primary Teacher/JBT could not be promoted on the post of DPE (Physical Education). Some of the Primary Teachers whose cases for promotion were under consideration as per the provisions of 1955 Rules, approached the Hon'ble High Court for consideration of their cases under the old rules by filing CWP No. 8287 of 2000 titled as Sukhwinder Singh Vs. State of Haryana in view of the principal of old vacancy old Rule. After hearing the writ on merits, Hon'ble High Court vide order dated 05.04.2002 had allowed the writ petition on the following grounds:-

1. That the petitioners were eligible at the time of commencement of 1998 rules w.e.f 12.05.1998. In other words, petitioners were eligible (requisite qualifications) during the prevalent of 1955 rules.
2. Vacancies were available and
3. The promotion process was under process.

In pursuance of abovementioned judgment, eligible petitioners were promoted.

Thereafter, the concerned branch put up the file with the proposal to promote the below mentioned candidates under the Rules, 1955 on the basis of judgment of Sukhwinder Singh (CWP 8287 of 2000). It is pertinent to mention that all these candidates did not have the requisite qualification prior to 12.05.1998 i.e. date of enforcement of 1998 Rules. All these candidates were promoted on the ground of old vacancy old rules, however, **the Principle of old vacancy old rules could not be applied on those who were not eligible at the prevalent of 1955 rules as all below mentioned-candidates did not have the requisite qualifications at such time.**

In view of the above explained position, it has been decided to revoke the promotion order No.17/135-2002 HRM-II(3) date 07.01.2008 and 2/9-2008 HRM-II(3) dated 11.10.2020 and revert all the ineligible DPEs who were not eligible for promotion at the relevant time.

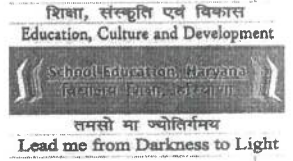
