Whereas a FIR No. 0022 dated 12.02.2015 was lodged against Sh. Jaimal, DPE GSSS Sambhi Distt. Karnal presently posted in GSSS Tikker Hills Distt. Panchkula. Thereafter, the delinquent was placed under suspension vide order dated 23.02.2015 and a chargesheet under Rule-7 of Haryana Civil Services (Punishment and Appeal) Rules, 2016 was also served upon him vide dated 26.06.2015. After completion of trial, delinquent was convicted and sentenced U/s 506, 34 of IPC and 6, 8 of POCSO Act. by Addl. Sessions Court (Trial Court) vide detailed judgment dated 03.08.2016 and 08.08.2016 respectively for the period of 10 years and with fine. Being aggrieved with the judgment of trial court, delinquent preferred appeal before the Hon'ble High Court vide CRA-S-3056-SB-2016 and the Hon'ble HC vide order dated 05.09.2016 admitted the appeal and order recovery of fine shall remain stayed during the pendency of appeal.


Subsequently, delinquent filed CRM vide CRM-35174 of 2016 for the suspension of sentence i.e. bail. The Hon'ble High Court vide order dated 01.08.2018 suspended the sentence of the delinquent and granted the bail (delinquent remained in jail for 3 years 7 months and 26 days.) However, it is a matter of record that the conviction of the accused/delinquent is still remaining in force and it has not been stayed by the Hon'ble High Court till date.

It is pertinent to mention here that the chargesheet is pending against the delinquent official and the services are reinstated vide order dated 06.06.2018. The matter has been reconsidered and I have gone through the whole matter and facts. At this stage, it is worthwhile to note that as per article 311(2) proviso (a) of the Constitution of India, it is stated that public servant can be dismissed or removed or reduced in rank without detailed inquiry if conduct of such employee has led to his conviction on a criminal charge. In the present case, it is a matter of

record that present delinquent stands convicted in view of judgment dated 03.08.2016/08.08.2016 and such conviction is still remaining in force.

In view of the above narrated facts, the undersigned being an appointing authority dismissed the services of the delinquent i.e. Sh. Jaimal, DPE, GSSS Sambhi, District Karnal present posted in GSSS Tikker Hills, District Panchkula under the provision of Article 311(2) proviso (a) of Constitution of India on account of conviction vide judgment dated 03.08.2016/08.08.2016 with immediate effect.
