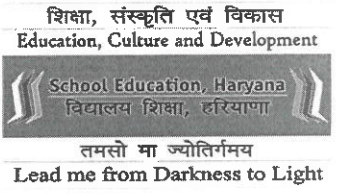

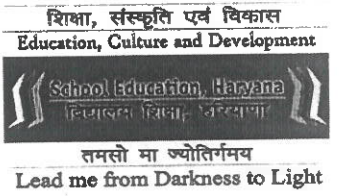

Whereas Smt. Meena Kumari, ESHM, Govt. Middle School, Pingli, District Karnal was served charge-sheet under Rule-7 of the Haryana Civil Services (Punishment and appeal) Rules, 2016 upon her vide order dated No. 04/25-2021 D&L (2) dated 16.06.2021 on the basis of report received from the District Elementary Education Officer, Karnal vide letter No. Steno /DEEO/21/997 on dated 09.04.2021.

After getting the charge sheet, the delinquent i.e. namely Smt. Meena Kumari, ESHM submitted her detailed reply with annexures on dated 07.09.2021. Therafter, the undersigned gone through from the reply and gave the opportunity of personal hearing and accordingly heard her at length on dated 08.12.2021.

After hearing and going through from the relevant records, I am of the view that proceeding under rule-7 is liable to be dropped on the following ground:-

- Smt Meena Kumari took the charge as ESHM in GMS Pingli on 04.08.2017 and at the time of joining, the bill of electricity metre was standing to the tune of Rs 58,746/-. She began the payment of electricity on 17.10.2017 as she made the payment of Rs 20,000/-. Therafter, on time to time she made number of payments. In this way, a sum of Rs 1,19,928/- towards electricity bill was made upto 24.12.2019. Due to adding up of previous arrears, the bill amount of Rs 90,207/- remained unpaid due to which meter was dis-connected for which the delinquent cannot be held responsible. Also, time to time she raised the issue of pending bill before SMC and concerned DEEO.
- The other allegations of misbehaviour with staff members of school and other members of panchyat and non-adherence of sanitization and masks instructions also found wrong.

In the light of above facts, the present proceeding under rule-7 of HCS (Punishment & Appeal) Rules, 2016 against the delinquent is hereby dropped.

Ordered accordingly.
