Whereas Sh. Rajesh Kumar approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No.21888/2020- Rajesh Kumar V/s State of Haryana & Others praying for the issuance of a writ in the nature of mandamus directing the respondent to promote the petitioner to the post of ESHM from the date junior/ similar situated to the petitioner has been promoted alongwith all consequential benefits by order dated 24.08.2019 (Annexure P-8), as the petitioner is also full eligible having all qualification to be promoted as per the Haryana School Education (Group-C) State Cadre Service Rules, 2012 (Annexure P-1).

The said petition came up for hearing before the Hon'ble High Court on 17.12.2020 and the following order was passed :-

*"This matter is being taken up for hearing through video conferencing due to the outbreak of pandemic, COVID-19.*

*Petitioner claims to be entitled for promotion to the post of Elementary School Head Master (ESHM) from the date his juniors/similarly situated employees have been promoted vide order dated 24.08.2019 (Annexure P-8))*

*Learned counsel for the petitioner submits that as per of Haryana School Education (Group C) State Cadre Service Rules, 2012, one of the conditions for promotion to the post of ESHM, is that a candidate should have a degree of B.A./B.Sc./one year Bachelor Degree in Education (B.Ed.) with at least 50% marks. However, as per notification dated 13.11.2019, requirement of minimum percentage of marks (50%) would not be applicable to those incumbents who had taken admission to the Bachelor of Education or Bachelor of Elementary Education or equivalent course prior to 29.07.2011. The present petitioner, it is submitted, had cleared his B.A. and B.Ed. prior to 2011, therefore, he is entitled to promotion in terms of the relevant Rules, even if he has not secured 50% marks in the said course*

*At this stage, learned counsel for the petitioner restricts his prayer for a decision on the legal notice dated 17.06.2020 (Annexure P-10), in a time bound manner.*

*Notice of motion.*

*Mr. Ashish Yadav, Addl. A.G., Haryana, accepts notice on behalf of all the respondents. Advance copy of the writ petition stands served. Learned counsel for the State does not raise any serious objection to the limited prayer addressed.*

*Keeping in view the facts and circumstances of this case, but without any expression of opinion on the merits of the matter, this petition is disposed of with a direction to the competent authority to consider and decide legal notice dated 17.06.2020 (Annexure P-10), by passing a speaking order within a period of three months from receipt of certified copy of this order.*

*Petition is disposed of accordingly.*

That, after receiving the direction from the Hon'ble High Court, the matter of the claimant i.e. Sh. Rajesh Kumar has been examined carefully and in the compliance of direction issued by the Hon'ble High Court in CWP No.21888/2020- Rajesh Kumar V/s State of Haryana & Others, the representation dated 17.06.2020 (Annexure P-10) has been examined and it has been found that initially the claimant i.e. Sh. Rajesh Kumar was

appointed as Mathematics Teacher on 12.02.2002 and joined the said post on 02.12.2002. He has passed B.A. with 46.5% in 1994 from KUK and B.Ed. with 57% in 1996 from MDU, Rohtak, hence, the claimant have requisite qualification as per NCTE norms i.e. mentioned in Rules,2012.

It is pertinent to mention here that as per Haryana Civil Services Rules, 2012, Appendix-B (Rule-7) the qualification for the promotion to the post of ESHM is as under:

It is pertinent to mention here that the case of claimant has been examined and it has been found that in the instant writ petition the claimant is working as TGT/Master. The answering department had called promotion cases from all the District Elementary Education Officers. Thereafter, the cases were examined as per the provision of Service Rules, 2012 by the departmental committee constituted for the said purpose. The promotion list was issued vide order No. 15/32-2019 HRM-III (1) on 24.08.2019 and left out cases for promotion order list issued on dated 17.02.2020/20.02.2020. The said promotion orders were issued upto seniority No. 2700 of General Category and 7900 of SC Category of TGTs by the answering department.

In the context explained above, the case of the claimant i.e. Sh. Rajesh Kumar in the instant writ petition has been examined and it has been found that the claimant i.e. Sh. Rajesh Kumar is at seniority No. 1806 in the seniority list dated 01.01.2017. The claimant i.e. Sh. Rajesh Kumar is eligible for promotion as per his seniority and his promotion case will be considered when the promotion case will be considered alongwith other promotion cases on the post Elementary School Head Master as per the vacancy available. It is relevant to mention here that rationalization process has been recently completed by the department and the process of examining the cases of all the

candidates eligible for promotion to the post of Elementary School Head Master will be initiated shortly as per Rules, vacancy, seniority and decision will be taken fairly in accordance with the Rules, vacancy, seniority. It is assured that the promotion case of the claimant i.e. Sh. Rajesh Kumar will be considered after examining the cases of juniors of the claimant as per their seniority, vacancy and Service Rules, 2012.

Now, considering the matter from all corner I found that the claim of the claimant will be considered at the time when the promotion will be made on the post of Elementary School Head Master. Hence, the claim of the claimant is under consideration.

Order accordingly.
