


Whereas a FIR No. 031 dated 04.02.2019 was lodged against Sh. Pardeep Singh, DPE, GMSSSS Tosham, Distt. Bhiwani. Thereafter, Sh. Pardeep Singh, DPE was placed under suspension vide order dated 05.03.2019 and was also dismissed from services vide order dated 15.01.2020. During the pendency of Criminal Case, Sh. Pardeep Singh, DPE filed petition before Hon'ble Bombay High Court for quashing of FIR. After considering the facts, the Hon'ble Bombay High Court quashed the FIR vide judgment dated 26.11.2019.

Being aggrieved with order dated 15.01.2020, Pardeep Singh, DPE filed the appeal on dated 20.01.2020 before the 1st Appellant Authority i.e. Director, Elementary Education, Haryana, Panchkula. After duly considering the judgment dated 26.11.2019 and the facts of the case, the dismissal order of delinquent was revoked vide order no. 14/3-2019 HRM-II(4) dated 25.02.2020.

It is pertinent to mention here that thereafter, the delinquent official also submitted representation dated 28.10.2021 in Directorate of Elementary Education, Haryana, Panchkula regarding treating the suspension period as duty period i.e. 05.02.2019 to 14.01.2020. The representation was considered in the light of Haryana Civil Services (General Rules, 2016). I have gone through the facts of the case it has observed that the above suspension period of the official be treated as duty period.

Hence, the suspension period (05.02.2019 to 14.01.2020) of Sh. Pardeep Singh, DPE, GMSSSS Tosham, Distt. Bhiwani is hereby treated as duty period.

Order accordingly.


