- 2. A certificate that the child belongs to the Scheduled Caste/Scheduled Tribe/EWS/CWSN, wherever applicable, issued by the competent authority.
- 3. A certificate from the civil surgeon/rehabilitation centre or any other competent authority defined by the State Govt. certifying the child to be handicapped, wherever applicable. In case, where the handicap of the child can be visually seen by the principal, the child may be accepted as handicapped even without a certificate. However, the parent/guardian may be advised to obtain the relevant certificate from the competent authority and submit the same to the school.
