

Whereas, a complaint dated 11.04.2018 was received from DEEO Kurukshetra against Sh. Dilbag Singh (078452), Math Master, Govt. Middle School, Yari (6463) Distt. Kurukshetra and after examining the complaint, the delinquent official Sh. Dilbag Singh, (078452), Math Master was charge sheeted U/R-7 vide this Directorate order no. 14/08-2018

HRM-I (3) dated 17.07.2018.

The official submitted his reply of chargesheet on 29.08.2018 and Sh. D.D. Gautam, IAS (Retd.) was appointed as an Inquiry officer vide order dated 16.10.2018 to conduct regular enquiry regarding charges leveled against the delinquent. The inquiry officer submitted the enquiry report dated 10.12.2018 with the conclusion that the charges leveled against the delinquent in the chargsheet dated 17.07.2018 are proved. Accordingly, a punishment of stoppage of one increment with cumulative effect was awarded to the delinquent Sh. Dilbag Singh, S.S. Master vide order no. 14/8-2018 HRM-I (3) dated 01.01.2021.

Being aggrieved with order dated 01.01.2021, Sh. Dilbag Singh filed the 1st appeal before the undersigned being competent authority against the order dated 01.01.2021 and opportunity of personal hearing was granted to him on 04.03.2022. After hearing in person, it has been found that Sh. Dilbag Singh, Math Master was DDO only for few days i.e. less than 15 days, therefore, the order dated 01.01.2021 is not justifiable and the same is set aside.
