A copy of policy dated 13.06.2022 issued by NCERT, Govt. of India, New Delhi regarding scheme for "National ICT Awards for School Teachers, Teacher Educators, Best Practicing States/UTs for the year 2020 and 2021" was shared with you wherein they have invited separate applications for 2020 & 2021 from

- the teachers of primary, upper primary, secondary and higher secondary level pertaining to State Govt. schools/ run by local bodies and Govt. Aided Schools (including the Govt. & Private Schools affiliated to State Board of Education)
- the teacher educators of BIETs, DIETs, CTEs, IASEs, SIEMAT, SCERTs, SIEs, SIETs and colleges, Universities run by State Govt. / IT administration and Private Universities (from 2021 onwards)

who have enhanced student learning by effectively and innovatively integrating technology supported learning into the school curriculum and subject teaching, and thereby promoted enquiry-based cooperative-collaborative learning using ICT among their students. You were also requested to do wide publicity of policy for encouraging the





eligible teachers to apply for award online alongwith full justification / documentary evidences latest by 30th June, 2022, the last date fixed by the Govt. of India.

Now, the NCERT, Govt. of India has exteded the last date for online self-nomination by Schol Teachers and Teacher Educations upto 31.07.2022.

You are, therefore, again requested to give wide publicity to the policy for encouraging the eligible teachers to apply for award through online portal i.e. www.ictaward.ncert.gov.in alongwith full justification / documentary evidences latest by the last date i.e. upto 31th July, 2022. Only online applications will be accepted by the Govt. and nominees/entrusted teachers need to register themselves on the portal i.e. www.ictaward.ncert.gov.in by proving mobile number or email id before closing date.
