Whereas Sh. Anand Prakash Goyal (ID-071027), ESHM, GMS Nangla, District Bhiwani was served charge-sheet under Rule-7 of the Haryana Civil Services (Punishment and appeal) Rules, 2016 vide order No. 04/02-2021 D&L (2) dated 17.06.2022 on the basis of inquiry report received from the District Elementary Education Officer, Bhiwani vide letter No. E-6/21/799 dated 21.06.2021 and Block Education Officer, Bhiwani vide letter No. E-III/19/5242 on dated 16.07.2019. After receiving the charge sheet, the delinquent i.e. namely Sh. Anand Prakash Goyal, ESHM, GMS Nangla, District Bhiwani submitted his reply vide dated 13.07.2022 wherein he refuted all the allegations and gave detailed reply against each charge along with the supporting annexures.

I have pursued all the relevant records and reply dated 13.07.2022 submitted by the delinquent. In the reply dated 13.07.2022, it is stated that there had been long tussle between the some primary teachers and the delinquent. Also, in the report dated 03.12.2020 headed by the DEEO Bhiwani, it was stated that behavior of present delinquent is cordial w.r.t. staff of Secondary, however, it is not cordial w.r.t. staff of primary. In this regard, delinquent submitted that as some undue financial benefits had been receiving by one head teacher and JBT which eventually stopped by him. Resultantly, they were trying to implicate him in false cases. For supporting his claim, various annexure have been provided by the delinquent vide reply dated 13.07.2022. Also, he stated in reply that he stooped the Mid Day Meal Cooks from taking kitchen work from students of school vide order no 449 dated 22.07.2016 and 563 dated 18.02.2017. As a result, such MID DAY Meal Cooks filed the complaint against him to DEEO Bhiwani. In short on the perusal of all relevant records, prima facie it appears that there had been altercation between them which led to the present charge-sheet.

In the light of above facts and Rule-7(5) of HCS (Punishment and Appeal) Rules, 2016, the present proceeding under Rule-7 of HCS (Punishment and Appeal) Rules, 2016 against Sh. Anand Prakash Goyal, ESHM, GMS Nangla, District Bhiwani is hereby dropped.

Ordered accordingly.


