Whereas a FIR vide FIR No. 109 dated 30.05.2010 under Section 148, 149, 323, 325 of IPC in the Police Station City Dadri was lodged against Sh. Rajesh Kumar, JBT, GPS Kakroli Hukmi, Block Badhra, District Charkhi Dadri and consequently was convicted by the Trial Court vide judgment dated 04.07.2015 in Criminal Case No. 262-I of 2010 titled as State of Haryana versus Hansraj and others for commission of offences under Sections 148, 323, 325 read with Section 149 of IPC for 18 months.

Thereafter, Sh. Rajesh Kumar, JBT alongwith other convicted persons filed a criminal appeal in the Court of Addl. District and Sessions Judge, Charkhi Dadri against the Judgment dated 04.07.2015 and the same was decided by the appellat Court vide judgment dated 18.01.2020 vide which the judgment of conviction has been affirmed and sentence of imprisonment has been reduced from 18 months to 12 months. In view of the above said judgments, Sh. Rajesh Kumar, JBT was dismissed from services by District Elementary Education Officer, Charkhi Dadri on 06.04.2021. Being aggrieved with judgment dated 18.01.2020, Sh. Rajesh Kumar alongwith others filed CRR No. 342 of 2020 in the Hon'ble Punjab and Haryana High Court, Chandigarh for setting aside the judgment dated 04.07.2015 passed by Trial Court and also judgment dated 18.01.2020 passed by the Addl. District and Sessions Judge, Charkhi Dadri.

Whereas, Sh. Rajesh Kumar, JBT also filed an administrative appeal before the Additional Director, Elementary Education, Haryana, Panchkula being 1st Appellant Authority against the dismissal order dated 06.04.2021. The delinquent was duly provided the opportunity of personal hearing. During the pendency of revision in the Hon'ble Punjab and Haryana High Court, Chandigarh against order dated 06.04.2021 and 18.01.2020, the Hon'ble High Court vide Judgment dated 30.03.2022 in CRR No. 342 of 2020 quashed the criminal proceedings related to FIR No. 109 dated 30.05.2010 and judgments dated 04.07.2015 and 18.01.2020

qua the petitioners in the light of compromise. Consequently, the appellant seeks re-instatement on account of quashing of FIR as well.

I have pursued all the relevant records submitted by Sh. Rajesh Kumar. After examining the facts of the case, the undersigned is of the view that it was a minor tussle among the delinquent and co-villagers while returning back after attending a Baraat and also as per Hon'ble High Court order dated 30.03.2022, the injuries were not on any vital part of the body. The compromise was also effected during the pendency of the revision petition as the parties are residents of the same village and have amicably resolved the dispute amongst themselves. It is also stated here that such dispute does not cause mental depravity and the offences do not fall in moral turpitude category.

In the light of above facts, the appeal of Sh. Rajesh Kumar, JBT, GPS Kakroli Hukmi, Block Badhra, District Charkhi Dadri is allowed and he is re-instated in the services.


