As per provision in the Haryana Civil Services (Compassionate Financial Assistance/Appointment) Rules, 2019 and on the recommendation of Director Secondary Education, Haryana, Panchkula vide Order No. 9/180-2021P-I(1) dated 13.07.2022 **Smt. Suruchi Rajput W/o Lt. Sh. Kulvinder, R/o A-1, Bank Colony, Near Boosting Station, Paluwas Mod, Bhiwani** is hereby appointed as Trained Graduate Teacher (TGT) English (HES-III) as posted in **GGSSS Kharak Kalan (Code- 0331) Distt. Bhiwani** against vacant post in the pay band FPL-7(44900-66000) of Haryana Civil Services (Revised Pay) Rules, 2016 plus usual allowances as admissible from time to time. She is directed to join at the place of posting as mentioned above.

**Terms and conditions:-**

1. She is appointed purely on temporary basis.
2. This appointment is against temporary post and her confirmation against substantive post shall be considered on the basis of her seniority and record of service as and when such post is available.
3. She shall have to take an oath of allegiance to the Constitution of India.
4. In case at later stage it is found that she again re-married than, this offer of appointment will be forfeited/cancelled & next eligible member of the family of deceased will be considered for the same as per entitlement as per rules.
5. She shall not be allowed to apply for any post outside the department for a period of at least five years.
6. She shall not claim seniority on the basis of this order. Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
7. She shall be on probation for a period of one year. The period of probation can be extended for a period not exceeding one year, if considered necessary.
8. In the matters, not specifically mentioned in this communication, she shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/ instructions as may be issued by the Government from time to time.
9. She is hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Elementary Education Officer concerned alongwith photostat self-attested copies. Concerned District Elementary Education Officer is directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
10. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
11. She shall be governed by the Haryana State Education School Cadre (Group-C) Service Rules-2012.
12. If at any time during the course of her temporary appointment, she desires to resign, then in such eventuality, she shall be required to give one month's notice or forfeit, in lieu thereof, her one month's salary including allowances etc.
13. No TA/DA will be admissible to the candidate for joining as TGT.
14. If she gets an appointment as TGT on the basis of her furnishing ineligible/invalid qualifications, false/forged or fraudulent information/

- facts which are detected later on, she would be liable for termination of service without any notice.
15. If she is willing to accept this offer of appointment as TGT, HES-III (School Cadre) on the above terms and conditions, she should submit her joining report as per aforesaid directions.
  16. Her services will be governed under the "New Defined Contributory Pension Scheme" of the Haryana Government as per Finance Department notification dated 28.10.2005.
  17. She is directed to join her place of posting within 15 days and send the joining report (duly signed by DDO) at [tgt1branch@gmail.com](mailto:tgt1branch@gmail.com), failing which this offer of appointment letter will be deemed to have been withdrawn.

Whereas a FIR vide FIR No. 692 dated 09.12.2020 under Sections 498-A, 323, 328, 307 of IPC and under Sections 3 & 4 of Dowry Prohibition Act 1961 in the Police Station Tappal, Distt. Aligarh, Uttar Pradesh was lodged against Sh. Jai Parkash Singh (009562), ESHM, GGMS Patuka (6581), Distt. Nuh and subsequently, the delinquent was placed under suspension vide order no. 14/2-2021 HRM-III (2) dated 19.02.2021 w.e.f. 10.12.2020 due to detention in Aligarh Jail.

Thereafter, a Chargesheet under Rule-7 of HCS (Punishment and Appeal) Rules, 2016 was issued to the delinquent vide order dated 12.10.2021. The delinquent submitted his reply to the chargesheet on 29.11.2021 and subsequently on 29.08.2022 alongwith the judgment dated 23.08.2022 passed by the Ld. District and Sessions Judge, Aligarh (U.P.). The delinquent was duly provided the opportunity of personal hearing on 23.08.2022, however, the delinquent remained absent on such date and subsequently present on 29.08.2022 for personal hearing. As per the judgment dated 23.08.2022, the delinquent was acquitted from all the charges under Sections 498-A, 323, 328, 307 of IPC and under Sections 3 & 4 of Dowry Prohibition Act 1961 by the Ld. Sessions Judge, Aligarh, (UP).

Whereas, after examining all the facts of the case, charge sheet, reply filed by the delinquent in response to the charge sheet, reply submitted during personal hearing and keeping in view judgment dated 23.08.2022 passed by the Ld. District and Sessions Judge, Aligarh, UP and in the light of Rule-7(5) of HCS (Punishment and Appeal) Rules, 2016, the present proceeding under Rule-7 of HCS (Punishment and Appeal) Rules, 2016 against Sh. Jai Parkash Singh (009562), ESHM, GGMS Patuka (6581), Distt. Nuh is hereby dropped.


