Whereas Sh. Ravinder Singh Ex. Drawing Teacher had submitted the medical bills to the Principal GSSS Sikri District Karnal and the said bills were received in the Directorate through DEEO Karnal vide his/her memo No. A-2-20/301 dated 08.10.2020. A sanction of amount Rs. 7,38,879/- was issued by the department vide memo no. 29/133-2020 HRC&V(2) dated 06.11.2020 in favour of Sh. Ravinder Singh Ex. TGT Drawing .

It is mentioned here that vide Advt. No. 6/2006 Category No. 22 the claimant namely Sh. Ravinder Singh was appointed as Drawing Teacher. That Advertisement was challenged in the Hon'ble High Court in LPA No.359 of 2015 titled as vinod kumar and others V/s state of Haryana & others by the some aggrieved teachers who were not selected against said Advertisement.

The above mentioned LPA was listed before Hon'ble High Court on 10.11.2020 for hearing and on the fixed date for hearing Hon'ble Court passed the following order the operative part of which is reproduced as under:-

“One last prayer which is made that in case this Court dismiss the appeals, it should at least permit the selected candidates to work till the fresh selections are made in terms of the judgment of the learned Single Judge. This precise contention was considered by the Supreme Court in Ramjit Singh Kardam's case in para No.74 (supra) and Their Lordships were pleased to reject it. In the circumstances, this plea is also rejected.

However, in the light of aforesaid judgment of Supreme Court, the candidates who had been selected and had worked on the post of Art & Crafts Teacher shall not be asked to refund any of the salary and other benefits received by them as against their working on the posts. No refund shall also be asked from those candidates, who after their selection worked and retired from service. Furthermore, the entire process be completed by the Commission within five months, which was the time fixed by the Ld. Single Judge for completing the process, in accordance with law.”

It is mentioned here that Sh. Ravinder Singh Ex. Drawing Teacher has submitted his medical bill amounting Rs. 7,38,879/- to this department for reimbursement and a sanction letter was issued by the department on 06.11.2020 to DEEO Karnal, Treasury Officer Karnal as well as to Sh. Ravinder Singh Ex. Drawing Teacher of Rs. 7,38,879/-.

However on 10.11.2020, the Hon'ble Court passed the aforementioned order wherein it is clearly stated that:-

“ the candidates who had been selected and had worked on the post of Art & Craft Teacher shall not be asked to refund any of the salary and other benefits received by them as against their working on post.”

The claim of the claimant namely Sh. Ravinder Singh Ex. Drawing Teacher was re-examined and it has been found that only sanction letter was issued and the sanctioned amount has not yet been received by the claimant. Hence, taking into consideration the order dated 10.11.2020 passed in LPA No. 359 of 2015 by the Hon'ble Court and case of the claimant it is stated that Sh. Ravinder Singh Ex. Drawing Teacher is not eligible for claiming benefits of medical bill and the sanction of medical bill of the treatment of his

mother amounting to Rs. 7,38,879/- which was issued to DEEO Karnal & others vide Memo No. 29/135-2020 HRC&V(2) dated 06.11.2020 is hereby withdrawn.

Ordered accordingly.
