Whereas, the present CWP No. 20942 of 2022 Rakesh Yadav Vs. State of Haryana and another for issuance of writ in the nature of Certiorari for quashing the impugned transfer order dated 28.8.2022 [Annexure P-5] whereby petitioner is transferred to Govt. High School Dhani Bhakra (642), Block Siwani, Distt. Bhiwani despite the fact that petitioner had opted Govt. High School, Block Dhani Bhakra, Bhiwani and for directing the respondents to allot school as per points and preference opted by petitioner after rectifying the mistake/error qua preference No. 45 (Government High School, Block Dhani Bhakra, Bhiwani), in the interest of justice.

The said petition came up for hearing before the Hon'ble High Court on 14.09.2022 and same has been decided by the Hon'ble High Court with direction on 14.09.2022. The operative part of the judgment dated 14.09.2022 is as under:-

"Mr. Harish Nain, AAG, Haryana accepts notice on behalf of the respondent-State and submits that in case, the petitioner has any grievance qua the transfer, the petitioner is at liberty to move appropriate representation raising the said grievance within a period of two days from today and in case, any such grievance is raised, the same shall be decided within a period of 10 days thereafter by passing an appropriate speaking order. Till then, the petitioner will not be relieved from the present place of posting or in case relieved, will not be forced to join the new place of posting till the decision of the said representation in case, the same is filed.

Learned counsel for the petitioner submits that keeping in view the statement of the learned State counsel, the present petition may kindly be disposed of having been not pressed any further with liberty to the petitioner to approach the respondents by filing appropriate representation raising the grievance as raised in the present petition.

Ordered accordingly .

The representationist submitted his representation to this directorate which was received on 20.09.2022. In this representation, the representationist stated that he was working as Elementary School Headmaster in Government Middle School Dhani Rahimpur (6452), Distt. Bhiwani. He had participated in Transfer Drive which was initiated from 25.08.2022 to 28.08.2022 and he opted 101 stations as preference. After this, on 28.08.2022, the department uploaded the transfer order through the portal. He stated that he was astonished to find that he was transferred to the Government High School, Dhani Bhakra, which is in Block, Siwani, which is 80 KM away from his house while teachers with less marks than him have been allotted nearby station which were selected by him despite the fact that he had chosen Government High School Dhani Bhakra Block Bhiwani. He also stated that next to the school name the block to which the school belongs was not

Government High School Dhani Bhakra (642), Block Siwani, Distt. Bhiwani on the basis of merit list, further, it is also relevant to mention here that no teacher having less marks than the claimant got a station which he opted from Sr. No. 1 to 44 of his preference during the Transfer Drive. The contention of the representationist is that no block name was mentioned before the name of the school in the preference list, in this regard it is pertinent to mention that a unique code of each school was mentioned with all school names. The representationist could check the block of school on MIS portal if he had any doubt. He was allotted preference No. 45 i.e. Government High School Dhani Bhakra (642), Block Siwani, Distt. Bhiwani on the basis of merit list. It is stated that he himself opted the said allotted station at the time of transfer drive.

It has been found that the transfer of the representationist is made keeping in the view of his MIS at the time of Transfer Drive as per Transfer Policy, 2016 on the basis of present circumstances, the claim of the representationist has been rejected in above terms.
