Whereas Smt. Suraj (083746), C&V Hindi, Government Sr. Sec. School Singhpura (2766), District Rohtak approached the Hon'ble Punjab & Haryana High Court at Chandigarh by way of filing a Civil Writ Petition No. 22706 of 2022- Suraj Vs. State of Haryana & others. The Hon'ble Court pleased to dispose of the writ petition on 30.09.2022 with direction to respondents.

In pursuance of these directions dated 30.09.2022, the transfer order of Smt. Suraj (083746) C&V Hindi, Government Sr. Sec. School Singhpura (2766), District Rohtak to Government Girls Sr. Sec. School Rohtak (2673) District Rohtak issued vide order No. 6/20-2022 TGT R&A dated 28.08.2022 which happened due to transfer drive is hereby cancelled with immediate effect. Therefore, she will remain at her old station i.e. Government Sr. Sec. School Singhpura (2766), District Rohtak.

Similarly in compliance of above order dated 30.09.2022, transfer order of Sh. Sant Kumar (083487), C&V Hindi, Government Sr. Sec. School Khidwali (2662), District Rohtak to Government Sr. Sec. School Singhpura (2766), District Rohtak issued vide order No. 7/9-2022 ESHM dated 09.09.2022 which happened due to transfer drive is hereby cancelled with immediate effect and he will adjusted at Government Sr. Sec. School Baniyani (2756), District Rohtak.

Order No. 17/40-2022 ESHM (1)

Dated Panchkula the, 12-12-22

Whereas, the present CWP No. 19811 of 2022 Wagish Kumar Duhan Vs. State of Haryana & Others for quashing impugned transfer order dated 28.08.2022 (P-11) vide which the petitioner has been transferred from GHS Nangal (438) District Bhiwani to GHS Kharkhara (1228) District Hisar as the same has been passed on the basis of updating incorrect zone to by the respondent department on MIS portal as the correct zone is 6 as per notification dated 23.06.2017 (P-9) and also by ignoring the merit points and the same is in violation of the Teacher Transfer Policy (P-1 to P-3) as the person with lower points have been given the stations which is opted by the petitioner. Further prayed for quashing the action of the respondents in forcing the petitioner to opt the stations against the post of language teachers i.e. the feeder cadre post, C&V Teacher (Hindi) and effecting the transfers through online transfer mode in mid-session in total contravention of the Teacher Transfer Policy dated 29.06.2016 (P-1) and amended policy dated 05.06.2017 (P-2). Further prayed for quashing the action of respondent in keeping various post blocked so as to exclude those posts from the transfer drive thereby complying the petitioner and similarly situated persons to forcibly participate in the Transfer Drive and direct the respondents to retain the petitioner at GHS Nangal (438) District Bhiwani by staying the operation of impugned transfer order dated 28.08.2022 (P-11) as no one has joined on the place of the petitioner i.e. at GHS Nangal (438).

The said writ petition was tagged with CWP No.19544 of 2022 and other connected cases and came up for hearing before the Hon'ble High Court on 05.09.2022 a common order was passed by Hon'ble Court. The operative part of the order is reproduced as under:-

"Keeping in view the above, the present petitions are disposed off having been not pressed any further.

It is directed that the respondents will abide by the undertaking as recorded hereinabove and further till the representation(s) are decided by the respondent-department, in case the petitioners have not been relieved so far, they be allowed to continue at their present place of posting so that in case claim of the petitioner(s) is accepted by the respondents, they do not suffer harassment or prejudice. It is made clear that in case claim of the petitioner(s) is not accepted by the respondents, the petitioners will be bound to comply with the order of transfer so as to join at their new place of posting.

In case, after the decision of the respondents, the petitioner(s) feel aggrieved, they will be at liberty to avail an appropriate remedy available with them for the redressal of their grievance".


That the claimant's representation dated 07.09.2022 was received on 09.09.2022 and after examining the representation it has been found that the claim of the claimant is to quash the transfer order dated 28.08.2022 (Annexure P-11) vide which the claimant was transferred from GHS Nangal (438), District Bhiwani to GHS Kharkra (1228), District Hisar as the transferred school has been shown at zone 2 on MIS whereas the correct zone is 6 as per the notification dated 23.06.2017 (P-9). It is stated that the claimant has participate in transfer drive and filled up more than 235 preference for his transfer and got the preferred school/station at Sr. No. 97 i.e. GHS Kharkra (1228) on the basis of MIS point 46.8438. It is relevant to state here that the answer to the grievance of

the claimant with respect to allocation of school and preference to C&V Teachers has been given vide letter dated 29.08.2022. The objective of giving priority to C&V Teachers (District Cadre) over TGTs (State Cadre) while allocating a school was to remove the administrative difficulty whereby few C&V Teachers were not able to find within their District due to inflow of TGTs from the outside the District due to TGTs having more marks within their District.

It is pertinent to mention here that the transfer drive was initiated from 25.08.2022 to 28.08.2022 and at the time of transfer drive GHS Kharkra (1228) was inadvertently shown at zone 2 instead of zone 6. Now, the rectification regarding zone has been made from zone 2 to zone 6 vide memo No. KW 8/2-2020 Coord. (2) dated 16.10.2022/15.11.2022. It is worthwhile to state here that the claimant was transferred at his preferred school on the basis of his merit points on him MIS profile i.e was transferred to his preferred station at Sr. No. 97 i.e. GHS Kharkra (1228), District Hisar.

In the context explained above, it has been found that the transfer of claimant was made keeping in view of points on his MIS at preferred school during the Transfer Drive as per Transfer Policy, 2016. On the basis of present circumstances, the claim of the claimant/representationist is not maintainable and hereby rejected in above terms.

I order accordingly.

Order No. 17/49-2022 ESHM (2)

Dated Panchkula the, 12-12-2022

Whereas, the present CWP No. 23062 of 2022 titled as Mohd. Haroon Vs. State of Haryana & Others for issuance of an appropriate Writ, Order or direction, especially in the nature of Certiorari, quashing the impugned notice dated 28.08.2022, Annexure P-2, and letter dated 01.09.2022 issued by the respondent, no. 2, being not sustainable in the eyes of law as petitioner was not allotted the preferential station as per the policy and same was allotted to the junior of the petitioner namely Naresh Kumar having low number to the petitioner i.e. 40 point and petitioner having 60 points pick and choose manner, posted at their present place of posting, with the same stroke, while issuing the notice of the same date 28.08.2022, Annexure P-5.

The said petition came up for hearing before the Hon'ble High Court on 10.10.2022 and the following order was passed :-

"Learned counsel for the petitioner argues that the petitioner has been transferred vide impugned order dated 28.08.2022 (Annexure P-2) though the colleagues of the petitioner having lesser points as envisaged in the transfer policy, have been granted the station, which was opted by the petitioner, hence, the respondents have violated the provisions of the transfer policy while effecting the transfer of the petitioner.

Learned counsel for the petitioner submits that for the grievance which has been raised in the present petition, the petitioner has already approached the respondents by serving upon them a legal notice dated 08.09.2022 (Annexure P-5), which is still pending consideration with the respondents and the petitioner will be satisfied, at this stage, in case a time bound direction is issued to the respondents to decide the said legal notice by passing an appropriate speaking order.

Notice of motion.

Mr. Harish Nain, learned Assistant Advocate General, Haryana, who is present in the Court, accepts notice on behalf of the respondents. Learned counsel for the respondents raises no objection in deciding the legal notice of the petitioner dated 08.09.2022 (Annexure P-5) in a time bound manner by passing an appropriate speaking order.

Without commenting upon the merits of the case or about the entitlement of the petitioner for the relief which has been claimed by him in the legal notice dated 08.09.2022 (Annexure P-5), the present writ petition is disposed of with a direction to respondent No.2 to decide the legal notice dated 08.09.2022 (Annexure P-5) within a period of eight weeks from the receipt of copy of this order."

In the compliance of above mentioned direction, the legal notice dated 08.09.2022 (Annexure P-5) of claimant has been examined in length and it has been found that the transfer drive was initiated from 25.08.2022 to 28.08.2022. The claimant had participated in the Transfer Drive and at the time of transfer drive the claimant had secured 60.2493 points as per his MIS profile as well as he has got the preference at Sr. No. 4 of his opted stations i.e. GMS Kourli (6052), Distt. Nuh Mewat.

It is the duty of the teachers him/herself to update their MIS Profiles after getting their documents verified from the concerned DDOs. It is also stated that many opportunities regarding verification/updating of service profile and personal profile were given to the teachers through concerned DEOs/DEEOs/ Principals/ Head of the institutions/DDOs to update the MIS Profiles of all teachers vide memo No. KW 8/2-2020 Co-I (2) dated 12.05.2022, Memo No. 1/101-2016-eGov.cell dated 11.07.2022 and memo No. 1/65-2022 eGov./IT Cell dated 17.08.2022. As per the MIS profile of the claimant, he is employee of Rest of Haryana Cadre not an employee of Mewat Cadre whereas Sh. Naresh Kumar (MIS point 40.7781) whose example was given in instant writ petition is an employee of Mewat Cadre, hence, the preference would be given to employees of their respective cadre instead of employees of Rest of Haryana cadres.

In view of the context explained above, it is worthwhile to submit here that the petitioner had participate in transfer drive as an employee of Rest of Haryana whereas Sh. Naresh Kumar had participated in Transfer Drive as an employee of Mewat Cadre so that preference has been given to Sh. Naresh Kumar in transfer of Mewat Cadre. Hence, the claim of claimant is not tenable as it is the duty of the teacher to update the MIS Profile before the Transfer Drive was initiated within the time period as mentioned above.

In the context explained above, it has been found that the transfer of the claimant is made keeping in the view of his MIS at the time of Transfer Drive as per Transfer Policy, 2016 on the basis of present circumstances, the claim of the claimant has been rejected in above terms.

I order accordingly.
