Whereas, Model Public School, Kapriwas, Rewari has been recognized vide order No. G-3/10/2 dated 31.03.2010 from class 1st to 8th by Deputy Commissioner-cum-Chairman of the District Committee, Rewari in exercise of power conferred under Rule 34 (6) of Haryana School Education Rules, 2003 (amended from time to time) with terms and conditions.

Whereas a complaint dated 07.08.2015 was received against your school through C.M. window Portal from Sh. Dharam Pal, wherein it was alleged that the said school was granted permanent recognition upto 8th level but the school is running classes upto 10th without recognition and permission of the appropriate authority. It was also alleged that the school is running on land which is different from the land of which lease deed is submitted by the school while applying for the recognition.

Taking cognizance on this complaint, the Directorate vide memo No. 6/64-2016 PS(E-2) dated 07.02.2018 issued a Show Cause Notice to your school that why the Recognition/ NOC granted to their school may not be withdrawn from the next academic session 2018-19. You replied in reference to Show Cause notice on dated 07.03.2018 and your reply was taken in record. You were provided opportunity of personal hearing on 31.01.2019 and you were heard at length. At the time of such hearing, you requested for grant of 6 months to shift the school building and you were granted accordingly. You were issued a letter dated 28.08.2019 by the Directorate whereby you were asked to submit the status report within a week, however, you did not submit status report.

As per the rule 42 (1)(b) of Haryana School Education Rules, 2003, the recognition of school shall lapse if a school is transferred to a different building or locality not already approved by appropriate authority. You shifted your school building without approval/ intimation to the Directorate. Hence, you violated the rules 2003, therefore, keeping in view of these facts and recommendations of the DEEO, Rewari, It is hereby ordered for the withdrawal of recognition (Order No. G-3/10/2 dated 31.03.2010) of

Model Public School, Kapriwas, Rewari under Rule 42 read with Rule 34 of Haryana School Education Rules, 2003 (amended from time to time) which come into effect from the next succeeded academic session i.e 2023-24.

- 1. That this promotion is subject to the final outcome of the decision of the year 2000 appointees and if any candidate of the year 2000 appointees will be promoted then they will be senior to the 2004 appointees and accordingly seniority will be fixed. In that situation, if reversion is required then the teacher will be reverted to his/her original post without any notice.
- 2. That this promotion subject to review/cancellation in case of any discrepancy regarding eligibility detected at any stage.
- 3. That the teacher will remain on probation for a period of one year, which can be extended in terms of Service Rules.
- 4. That this promotion order is without prejudice to the right of the seniors, if any, whose promotion cases may be decided at a later stage.
- 5. That this promotion is subject to the condition that no adverse remarks regarding integrity are found in his/her ACRs.
- 6. That seniority in the TGT/ Master cadre will be determined as per instructions/ Rules issued from time to time by the Govt. / Department.
- 7. That the teacher should fulfill the conditions of educational qualifications/ experience/ subject combination as per the service rules. In case it transpires at any stage that the teacher is ineligible for this promotion, the teacher will be reverted to his/her original post without any notice.
