Subject: Extension/ provisional affiliation of one year to Private Schools

for the academic session 2022-2023.

Your attention is invited on the subject cited above. It is to inform you that the Department was in receipt of several representations from the Private School Associations requesting for extension of provisional/temporary affiliation granted to the schools. Whereas, it is quite essential to take cognizance and safeguard the interests of the students studying in such schools. Thus, the Government after due deliberation and consultation has decided to grant provisional affiliation for another academic session i.e. 2022-23 only to such schools which were established before 30.04.2003 and whose cases of recognition have not been finalized by the Department/DLC, only if the school concerned give affidavit that they will not take admission after the academic year 2022-23 for those classes, which the school is not permanently recognized till the permanent recognition for these classes is obtained from the Directorate through proper channel. Draft affidavit is annexed as **Annexure-A**.

Therefore, you are hereby directed to inform all the concerned to submit their affidavits till 27.01.2023 in the office of concerned DEOs and the concerned District Education Officer prepare a consolidated list in Excel Sheet in the following format:
