Memo No. 6/31-2021 PS (E-1)

Dated, Panchkula, the 23-02-2023

Whereas, Baba Balak Nath Public School, Gohran, Kaithal was recognized vide order No. PSR092020467 dated 21.12.2020 from class 1st to 8th under Rule 12(4) of Haryana State Right of Children to Free and Compulsory Education Rules, 2011 with terms and conditions, for the purpose of Section 18 of Right of Children to Free and Compulsory Education Act, 2009.

Whereas a complaint dated 07.04.2021 was received against your school through Sh. Neeraj Rana S/o Sh. Jagmal Rana, R/o VPO. Gohran, Distt. Kaithal, wherein following allegations were made:-

1. That the said school is run in illegal manner and request to take legal action.
2. That the school was built on Panchayat Land i.e Khewat No. 75 Min, Khatoni No. 154, Murabba Khasra No. 21/25/1, Rakba 5 Kanal 6 Marla which is illegal.
3. That the School Manager is running the school by misleading the Govt. Department.
4. That the school is running upto 12th class.

After receiving the complaint, an Inquiry Officer was appointed to conduct an enquiry in this matter vide memo No. 6/31-2021 PS(E-1) dated 18.08.2021. Inquiry Officer submitted its enquiry report on 22.12.2021 vide memo no. 3/13-2021 JD(2). As per the Inquiry report, District Revenue Officer got the document (Land Certificates submitted by School Manager and complainant) verified through Sub-Tehsildar and submitted its report on 03.11.2021 to the Inquiry Officer. As per this report school building is established on Panchayat Land i.e. Khewat No. 75, Khatoni No. 154, Khasra No. 25/1(5-6) of Murraba No. 21. It is pertinent to mention here that a lease deed was submitted for recognition. In this lease deed, the land was shown as Murraba No. 19, Killa No. 2, Min (2.0), 9/1(6.0) besides this fact the building is established on different land i.e. Khewat No. 75, Khatoni No. 154, Khasra No. 25/1(5-6) of Murraba No. 21. The delinquent school knowingly concealed this fact to the Directorate.

On perusal of Inquiry report, the DEEO, Kaithal was directed vide letter No. 6/31-2021 PS(E-1) dated 22.04.2022 to issue Show Cause Notice to the School Management. In compliance of the said letter DEEO, Kaithal issued Show Cause Notice to the delinquent school and provided an opportunity of personal hearing. The DEEO, Kaithal intimated the Directorate the same vide letter No. PS/22/1811 dated 07.11.2022 and recommended for withdrawal of recognition as the school manager failed to submit relevant record and concealed the true facts. After taking into consideration the letter dated 07.11.2022, opportunity of personal hearing was granted to School Management on 16.02.2023 vide letter No. 6/31-2021 PS(E-1) dated 23.01.2023. The School's Principal

was present at the time of hearing wherein she was heard at length. However, She failed to rebut the allegations made against the school. Hence, it has been proved that present school is running on the Panchayat Land which is a clear cut violation of Statutory Rules.

Hence, taking into consideration above mentioned facts and in exercise of power conferred upon undersigned under Rule 13(3) of HRTE Rules 2011(amended on 11.05.2022) hereby order for withdrawal of recognition of Baba Balak Nath Public School, Vill. Gohran, Distt. Kaithal which will come into effect from the next succeeded academic session i.e. 2023-24.
