Order No. 17/23-2022 ESHM (1)

Dated Panchkula the, 17-3-23

Whereas, the present CWP No. 7547 of 2022 Ajit Singh and others Vs. State of Haryana & Others for quashing the impugned promotion order dated 15.03.2021 (Annexure P-3) vide which persons junior to the petitioners have been promoted; further a writ in the nature of certiorari quashing the impugned seniority list dated 01.06.2021 (Annexure P-4) which has been issued without fixing the quota and without roster. Further prayed for directing the respondents to revise the seniority of the petitioners as per the service rules and to prepare the seniority list as per the 7% quota prescribed in the Haryana School Education (Group C) State Cadre Rules, (Annexure P-1);

The said writ petition came up for hearing before the Hon'ble High Court on 03.08.2022 and the following order has been passed:-

"Learned counsel for the petitioners argues that the tentative seniority list dated 01.06.2021 (Annexure P-4), which has been framed by the respondents, is contrary to the facts on record as the petitioners are senior to respondent No.4, whereas in the said tentative seniority list dated 01.06.2021, respondent No.4 has been shown senior to the petitioners arbitrarily, to which act of the respondents, the petitioners have already raised objections, a copy of which has already been appended as Annexure P-5.

Learned counsel for the petitioners submits that the petitioners will be satisfied at this stage, in case the respondents are directed to finalize the said seniority list dated 01.06.2021 (Annexure P-4) in a time bound manner, keeping in view the objections raised by the petitioners, vide Annexure P-5, so that grievance of the petitioners is redressed.

Notice of motion.

Mr. Harish Nain, AAG, Haryana, keeping in view the advance service of the copy of petition, accepts notice on behalf of the State and submits that seniority list dated 01.06.2021 (Annexure P-4) will be finalized by the authorities concerned within a period of six months from the date of receipt of the copy of this order, if not done so far.

Faced with this situation, learned counsel for the petitioners submits that keeping in view the statement made hereinbefore by learned State counsel, no further grievance of the petitioners survives in the present petition and the same may kindly be disposed of as having been not pressed any further at this stage.

Ordered accordingly".

In pursuance of this order dated 03.08.2022 of the Hon'ble High Court, the seniority list dated 01.06.2021 was re-examined by the department. It is worthwhile to state here that the seniority list dated 01.06.2021 is based on seniority list dated 01.04.2016 of ESHMs. There are number of errors/mistakes found in the seniority list dated 01.04.2016 which has already been challenged in number of writ petition pending before the Hon'ble High Court. Hence, the seniority list dated 01.04.2016 has been amended keeping in view the pending writ petition/representations in the department and thereafter updation has been made in the seniority list dated 01.06.2021 accordingly. Objections called from the fields on the amended seniority list 01.04.2016 and updated tentative seniority list 01.06.2021 after uploading the seniority list on the official web-site of the department on 08.02.2023.

In other words, the department had granted 10 days' time to raise the objection, if any, upon on the combined seniority list uploaded on web-site on 08.02.2023 so that seniority list dated 01.04.2016 and 01.06.2021 may be amended/updated and will be finalized after removal of objections received from the field offices accordingly.

It is worthwhile to mentioned here that the Elementary School Headmaster is a 100% promotional post and as per provision in Haryana State Education School Cadre (Group-C) Service Rule-2012 sub Rule 9 (1) (a), the 100% vacancies of ESHM would be filled up through promotion only. The bifurcation of vacancies are as under:

9. (1) Recruitment in the Service shall be made: -

(a) In the case of Elementary School Head Master--

(i) 85% by promotion from amongst TGTs; and

(ii) 7% by promotion from Hindi teachers; and

(iii) 7% by promotion from Sanskrit teachers; and

(iv) 1% by promotion from Punjabi teachers; or

(v) by transfer or deputation of an official already in service of any State Government, Government of India or from the Haryana State Education School Cadre (Group C) Service ;

Keeping in view of above criteria, the promotion case of TGTs/C&Vs were considered as per Service Rules-2012 and thereafter, the name of said ESHMs mentioned in seniority list of ESHMs as per Rule-11(1) for the purpose of promotion on the post of High School Headmaster. It is very much relevant to mention here that the post of Head Master of High School is 100% promotional post amongst the ESHMs/TGTs. Hence, no separate seniority list of ESHMs could be prepared as per 7% Quota mentioned as above.

In the context explained above, it is worthwhile to submit here that the seniority of an employee of a cadre will be fixed/prepared as per Rule-11(1) of the Haryana School Education (Group C) State Cadre Service, 2012 which is mentioned as under:-

11. (1) *Seniority, inter-se of the members of the service, shall be determined by the length of continuous service on any post in the Service:*

Provided that where there are different cadres in the Service, the seniority shall be determined separately for each cadre:

Provided further that in the case of a member appointed by direct recruitment on contract basis, the order of merit determined by the recruiting agency shall not be disturbed in fixing the seniority:

Provided further that in the case of two or more members appointed on the same date, their seniority shall be determined as follows:-

- (a) a member regularized shall be senior to a member appointed by promotion or by transfer;*
- (b) a member appointed by promotion shall be senior to a member appointed by transfer;*
- (c) in the case of a member appointed by promotion or by transfer, seniority shall be determined according to the seniority of such members in the appointments from which they are promoted or transferred; and*
- (d) in the case of members appointed by transfer from different cadres, their seniority shall be determined according to pay, preference being given to a member, who was drawing a higher rate of pay in his previous appointments, and if the rates of pay drawn are also the same, then by the length of their service in the appointments and if the length of such service is also same, the older member shall be senior to the younger member.*

Keeping in view of above mentioned rule, it is relevant to state that the seniority list of ESHMs are to be issued for the purpose of promotion for the post of High School Headmaster, which is prepared on the basis of length of continuous service. Hence, it is not practically possible for department to create separate seniority list for TGTs & C&Vs as ESHM is a Single Cadre.

In view of the above narrated facts, that the seniority list of ESHMs are under process and same will be finalized/issued within a reasonable time.

I order accordingly.
