On the recommendation of Haryana Staff Selection Commission, Panchkula conveyed vide their Memo No. HSSC/Confd./Recomm./2022/4903 dated 13.10.2022, the following candidates are hereby appointed as Trained Graduate Teacher (TGT) English (HES-III) (Rest of Haryana Cadre) in the pay scale of Rs. 9300-34800 + Grade Pay 4600/- plus usual allowances as admissible from time to time. They are directed to join at the place of posting as mentioned below:-

Terms and conditions:-

- 1. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
- 2. He/She shall have to take an oath of allegiance to the Constitution of India.
- 3. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
- 4. He/She shall not be allowed to apply for any post outside the department for a period of at least five years.

- 5. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
- 6. He/She shall be on probation for a period of one year. The period of probation can be extended for a period not exceeding one year, if considered necessary.
- 7. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/ instructions as may be issued by the Government from time to time.
- 8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
- 9. Candidates are hereby directed to produce his/her original certificates of academic qualifications and other relevant certificates to the District Elementary Education Officer concerned alongwith photostat self-attested copies. Concerned District Elementary Education Officer is directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
- Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
- 11. He/She shall be governed by the Haryana School Education (Group-C) State Cadre Service Rules-2012.
- 12. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
- 13. No TA/DA will be admissible to the candidate for joining as TGT.
- 14. If he/she gets an appointment as TGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information/

- facts which are detected later on, he/she would be liable for termination of service without any notice.
- The appointment will be subject to the final outcome of CWP 15. No.10442/2019, 10685/2019, 15793/2019, 10612/2019 etc. & any Others and SLP No. 17134 of 2021 pending for adjudication in the Hon'ble High Court and Hon'ble Supreme Court of India.
- If he/she is willing to accept this offer of appointment as TGT, HES-III (16. Rest of Haryana Cadre) on the above terms and conditions, he/she should submit his/her joining report as per aforesaid directions.
- He/She is directed to join his/her place of posting within 15 days and send 17. the joining report (duly signed by DDO) at tgt1branch@gmail.com failing which this offer of appointment letter will be deemed to have been withdrawn.
- The said appointments are purely provisional subject to verification of 18. character and antecedents of the candidate concerned, however, it should be got verified within stipulated period. This relaxation does not confer any right to a candidate to remain in job, if subsequently anything adverse is reported against him/her at later stage as mentioned in Government Instruction No. 52/08/2022-3GS-III dated 23.06.2022.
