Whereas the names of the candidates as per list attached were recommended for the post of TGT English (Rest of Haryana) vide No. HSSC/Conf./Recomm/2022/4903 dated 13.10.2022 against Advt. No. 9/2015, Category No. 1 by Haryana Staff Selection Commission, Panchkula. While, recommending the name of the selected candidate, the HSSC, Panchkula had made an observation as under:-

“The selected candidates have not been medically examined and no special enquiry into their antecedents has been made. The documents pertaining to their Education Qualification, age, Caste/Category and Universities as claimed by them in the application form may please be got checked/verified from the issuing authorities, before they are allowed to join their duties. A copy of the appointments letter issued to the candidates may also be endorsed to the Commission.”

Accordingly, Document Verification Committee was constituted to verify the documents of selected candidates. All the candidates were called for verification of their documents on 20.10.2022 & 21.10.2022 vide Order No. 2/9-2023 TGT R&A (1) dated 19.10.2022 but these candidates were remained absent on 20.10.2022 & 21.10.2022 during the verification of documents.

Thereafter, last opportunity for verification of their documents was given by the department on 26.10.2022, but they again failed to appear before document verification committee.

Whereas, a show cause notice has been served upon you vide order No. 2/9-2022 TGT R&A (1) dated 29.03.2023 and the same was also uploaded on departmental website to show cause as to why the recommendation for cancellation of your candidature be not made to the recruiting authority, but no reply to the show cause notice received nor you appeared for verification of documents.

Keeping in view of the above, your candidature for the post of TGT English (Rest of Haryana) recommended by recommendation No. HSSC/Conf./Recomm./2022/ 4903 dated 13.10.2022 is hereby cancelled.
