Whereas the names of the candidates as per list attached were recommended for the post of TGT Physical Education (Rest of Haryana) vide No. HSSC/Conf./Recomm/2018/1061 dated 10.01.2019 against Advt. No. 3/2015, Category No. 2 by Haryana Staff Selection Commission, Panchkula.

Accordingly, Document Verification Committee was constituted to verify the documents of selected candidates. All the candidates were called for verification of their documents.

After document verification, appointment letter have been issued to the eligible candidates. In the appointment letter issued to the selected/eligible candidates there was a condition which is as under:-

*"He/She is directed to join his/her place of posting within 15 days and send the joining report (duly signed by DDO) failing which this offer of appointment letter will be deemed to have been withdrawn."*

But you were not joined in the stipulated time as per above said condition.

Whereas the names of the candidates as per list attached were recommended for the post of TGT Physical Education (Rest of Haryana) vide No. HSSC/Conf./Recomm/2018/1061 dated 10.01.2019 and HSSC/Conf./Recomm/2019/827 dated 20.12.2019 against Advt. No. 3/2015, Category No. 2 by Haryana Staff Selection Commission, Panchkula. While, recommending the name of the selected candidate, the HSSC, Panchkula had made an observation as under:-

“The selected candidates have not been medically examined and no special enquiry into their antecedents has been made. The documents pertaining to their Education Qualification, age, Caste/Category and Universities as claimed by them in the application form may please be got checked/verified from the issuing authorities, before they are allowed to join their duties. A copy of the appointments letter issued to the candidates may also be endorsed to the Commission.”

Accordingly, Document Verification Committee was constituted to verify the documents of selected candidates. All the candidates were called for verification of their documents on 24.01.2019 & 25.01.2019 vide Order No. 2/3-2019 TGT R&A (1) dated 21.01.2019 and on 19.02.2020 vide Order No. 2/3-2019 TGT R&A (1) dated 13.02.2020 but these candidates were remained absent during the verification of documents.

Thereafter, last opportunity for verification of their documents was given by the department on 11.02.2019 and 13.07.2020, but they again failed to appear before document verification committee.

Keeping in view of the above, your candidature for the post of TGT Physical Education (Rest of Haryana) recommended by recommendation No. HSSC/Conf./Recomm/2018/1061 dated 10.01.2019 and HSSC/Conf./Recomm/2019/827 dated 20.12.2019 is hereby cancelled.
