Whereas, Sh. Arshad Ali, is working as TGT SS (Guest) in Government Girls Senior Secondary School, Ahmadbass District Nuh. That vide memo no. 2178/VO-34/2022 dated 15.06.2022, an enquiry report was received from Superintending Engineer/Vig, HPU's, Panchkula. The said enquiry report was also received from Under Secretary/HR-II, SE/Admn. DHBVN, Hisar on 18.07.2022. From perusal of letter dated 15.06.2022, it is revealed that a complaint was made by Er. Mamman Khan, MLA Firozpur Jhirka, Haryana regarding making false case of theft of electricity and the same has been investigated by Insp. Jai Bhagwan, Police Post, Mewat. In this enquiry report, it has been stated that Sh. Arshad Ali, TGT SS (Guest) Government Girls Senior Secondary School, Ahmadbass District Nuh conspired with others i.e. Sh. Narayandas, J.E., Sh. Satbir Singh, Lineman and Sh. Sabhan Khan, Lineman regarding making false case of theft of electricity in the premises of Er. Mamman Khan, MLA. The Insp. Jai Bhagwan in his investigation report has recommended to take appropriate action against Sh. Arshad Ali, Guest Teacher.

Sh. Arshad Ali, TGT SS (Guest) had been removed vide order dated 20.02.2023 by the Additional Director, Administration, Directorate of Elementary Education, Haryana, Panchkula. The appellant (Sh. Arshad Ali) has filed the present appeal dated 03.04.2023 against the order of removal dated 20.02.2023 passed by Additional Director Administration, Directorate of Elementary Education, Haryana, Panchkula. The due opportunity of personal hearing was given to the appellant on 07.06.2023.

During the course of personal hearing, appellant stated that he is innocent and the allegations levelled against the appellant by Sh. Mamman Khan, MLA, assembly (constituency, Ferozpur Jhirka)(Complainant) are baseless and the same are levelled due to a reason that the appellant had not supported him during the previous assembly election and due to this reason he was annoyed with the appellant. The appellant further submitted that the complainant has misused his power and levelled false allegation against appellant. The appellant had never visited the house of complainant and has no concern with the making of false case of theft of electricity. The appellant does not know about LL-1 and its purposes. The appellant submitted that till date, no case of theft electricity theft case has been registered against him with regard to alleged occurrence. During the hearing, the appellant also furnished Notary Attested affidavit dated 07.06.2023 to the effect that no criminal case lying or pending against him neither he was convicted in any criminal case.

I have examined facts, circumstances and documents on record and also heard the appellant Sh. Arshad Ali. After considering relevant records, it is found that the name of the appellant has not been mentioned in the FIR lodged by the Sh. Aabeed Hussain. Moreover, no case of theft of electricity has been lodged by Electricity Department. In the enquiry report of Sh. Jai Bhagwan, Incharge Irrigation Power Nuh (Mewat), appellant has been found involved merely on the basis of statements made by the some electricity officials. There is no other evidence except the above statements against the appellant.

In view of the above of facts, as per the record, the appellant has not been charge sheeted by the Police Authorities at this stage. At present, neither

any criminal case is pending against him nor the appellant has been convicted in any criminal case as declared by the appellant in his affidavit dated 07.06.2023. Hence, the appellant could not be removed from service without any concrete evidence. It is also worth noticing that appellant had been serving as a Guest Teacher since 22.12.2005 till his removal and there are no allegation of indiscipline reported against appellant except the present proceedings.

In view of facts and circumstances mentioned above, the present appeal of the appellant is accepted and the impugned removal order dated 20.02.2023 passed by the Additional Director, Administration is hereby set aside. However, if the appellant is found to be guilty by competent court of law in future, then the competent authority is directed to take appropriate action against the appellant as per law.
