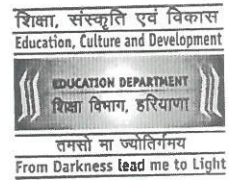

Whereas, the present CWP No. 17560 of 2022 Vikram Jeet and Ors. Vs. State of Haryana & Others for issuance of a writ in the nature of mandamus directing the respondents to unblock the post which have been blocked illegally and to include the same in the transfer drive so as to enable the petitioners to opt for the same. Further prayed for directing the respondents to rectify the MIS profile of the petitioners including zones and to upload the marks in question in accordance with the Transfer policy (P-1, P-2 & P-3) as per grievances of the petitioners (P-8 to P-11) so as to enable the petitioners to opt the station as per their merit points.

The said instant writ petition came up for hearing before the Hon'ble High Court on 23.08.2022. The operative part of the order passed by the Hon'ble High Court is as under-

*"Learned counsel for the petitioners submits that the petitioners have a grievance with regard to their compulsory participation in the transfer drive keeping in view the fact of each petitioner as stated in the petition. Learned counsel submits that some of the petitioners have a grievance that as per the transfer policy they are entitled for the marks keeping in view the ailment being suffered either by them or their family members or on some other valid ground as permissible in the transfer policy.*

*Learned counsel for the petitioners further submits that five of the petitioners have a grievance that their zone has not been fixed properly, which is causing prejudice to them. Learned counsel for the petitioners submits that the petitioners have already raised the said grievance before the authorities concerned by filing representations and they will be satisfied, at this stage, in case a time bound direction is issued to decide the said plea of the petitioners.*

*Learned State counsel submits that though a reply has already been filed but he has instructions to submit that the representations filed by the petitioners Annexures P-8 to P-11 will be decided within a period of seven days from today and the transfer, if issued in the meanwhile, will only be implemented after the passing of the order on their representations.*

*Learned counsel for the petitioners submits that keeping in view the statement of learned State counsel, the present petition may kindly be disposed of having been not pressed any further.*

*Ordered accordingly."*

In the compliance of above mentioned direction, it is stated that there are 15 claimants out of which 14 claimants are working on the post of PGTs, Directorate of Secondary Education is competent authority to decide the representation/claim w.r.t. these 14 claimants. Only claimant No. 9 is related to this Directorate of Elementary

Education as he is working on the post of Elementary School Headmaster. The case of claimant No. 9 i.e. Sh. Dharmender Singh in the instant writ petition has been examined carefully and it has been found that he was promoted on the post of Elementary School Headmaster on 24.08.2019. It is brought to your notice that recently Transfer Drive was opened from 25.08.2022 to 28.08.2022. The claimant had participated in the Transfer Drive and had opted more than 6 options for his transfer and he has got the station/school of his preference at Sr. No. 6 i.e. GGMS Asadpur Nandnaur (3659), Sonipat in round-1 during General Transfer Drive-2022. That as per the Annexure P-8 annexed by the claimant i.e. Sh. Dharmender Singh in the instant writ petition he has requested to continue his service at GMS Liwaspur (3505), Sonipat as he has not completed 5 year service in zone-2. It is pertinent to mention here that the claimant was manually adjusted vide order No. 15/32-2019 HRM-III (1) dated 21/22.11.2019 at GMS Liwaspur (3505), Sonipat on the post of ESHM with condition to participate in the upcoming transfer drive for regular posting. Hence, the claimant was included in General Transfer Drive compulsorily due to above said manual posting.

In view of the above narrated facts, I, undersigned, is of the considered view that the claim of the Claimant/ Representationist is not maintainable as he got the station/school of his preference at Sr. No. 6 i.e. GGMS Asadpur Nandnaur (3659), Sonipat in round-1 during General Transfer Drive-2022. Hence, it is stated that the claim of the claimant is not maintainable at this stage and hereby rejected in above terms.

I order accordingly.
