Whereas Smt. Suman Lata [1031003], JBT Teacher, GPS Markana, Distt. Kurukshetra preferred CWP No. 19117 of 2021 titled as Suman Lata Vs. State of Haryana & Others before the Hon'ble Punjab and Haryana High Court at Chandigarh seeking for direction to consider her claim for promotion to the post of TGT English HES-III (School Cadre) w.e.f. 17.07.2018 in the pay matrix FPL-7 (44900-142400) as sanctioned by the Haryana Government from time to time in officiating capacity.

Perusing the judgment dated 23.04.2019 in another CWP No. 10054 of 2016 Smt. Suman Lata has been found entitled for promotion on post of TGT (English) being having educational qualifications of B.A, and D.Ed. and with experience as JBT Teacher. Now, She is promoted on the post of TGT (English) w.e.f. 17.07.2018.

The above promotion is subject to the following terms and conditions:-

1. That this promotion is subject to review/cancellation in case of any discrepancy regarding eligibility detected at any stage.
2. That this promotion order is without prejudice to the right of the seniors, if any, whose promotion cases may be decided at a later stage.
3. That this promotion is subject to the condition that no adverse remarks regarding integrity are found in his/her ACRs.
4. That seniority in the TGT/ Master cadre will be determined as per instructions/ Rules issued from time to time by the Govt. / Department.
5. That the teacher should fulfill the conditions of educational qualifications/ experience/ subject combination as per the service rules. In case it transpires at any stage that the teacher is ineligible for this promotion, the teacher will be reverted to his/her original post without any notice.
6. That the posting order of the promoted teacher will be issued later on separately.

SCHOOL EDUCATION DEPARTMENT, HARYANA**ORDER****Memo No. 6/64-2016 PS (E-2)****Dated, Panchkula, the 23-08-2023**

Whereas an appeal dated 26.05.2023 has been made by Model Public School, Vill. Kapriwas, Distt. Rewari for setting aside the order dated 02.01.2023 passed by Director Elementary Education, Haryana vide which the recognition (Order No. G-3/10/2 dated 31.03.2010) of said school was withdrawn w.e.f. academic session 2023-24 for violation of Rule 42 (1) (b) of Haryana School Education Rules, 2003 by shifting the said school to a different building or locality without any approval by/of the appropriate authority.

Whereas, an opportunity of personal hearing was provided by the undersigned on 08.06.2023, 26.06.2023 and thereafter on 10.08.2023. The authorities of the said school appeared before the undersigned for personal hearing on 10.08.2023 and put up their part of defense in the present case and stated that they did have the provisional permission for doing the same (i.e. shifting of school to a different building or locality) and also stated that their only fault was that they didn't inform about the same to the Department. It has also been claimed by the appellant that after the cancellation order dated 02.01.2023, the said school was inspected and found to be as per norms.

The appellant also stated that since the school has two Acre land as per norms, therefore, there is no requirement of CLU of 2000 Sq.mtr in the name of School. The contentions made by the appellant have been heard by the undersigned and in this regard argument of the appellant is found to be prima-facie true. Therefore, in view of the facts stated above and the admission of fault by the appellant regarding for not intimating the department about having the permission to shift the school to a different building or locality, it seems that the order dated 02.01.2023 issued by the Director Elementary Education was not as per norms as the same was issued on the ground that the school had shifted the building to a different one other than the approved one without any permission from the appropriate authority.

Hence, in view of the Rule 43 (4) of Haryana School Education Rules, 2003, the undersigned being an appellate authority is of the considered view that the order dated 02.01.2023 issued by Director Elementary Education is liable to be quashed and accordingly hereby quashed with a liberty to the Department to have another inspection done and if the new building does not fulfill the norms then a fresh show cause notice may be issued accordingly as per norms.

Order accordingly.


