## DIRECTORATE OF ELEMENTARY EDUCATION HARYANA, PANCHKULA

Order No. 17/49-2023 ESHM (2)

Dated Panchkula the, 1-9-23

Whereas, the present CWP No. 5621 of 2023 Ravinder Singh Vs. State of Haryana & Another for issuance of a writ in the nature of certiorari for quashing the impugned promotion order dated 15.03.2021 (Annexure P-8), to the post of Head Master High School inter alia being against Haryana State Education School Cadre (Group-B) Service Rules, 2012 hereinafter referred to as Group-B Service Rules, 2012 (Annexure P-1) order dated 22.12.2015 (Annexure P-5) passed by this Hon'ble High Court in CWP No. 12949 of 2014 titled as Paramjit Sharma and another Vs. State of Haryana alongwith CWP No. 4301 of 2013 titled as Sartaj Singh Dhanda and other Vs. State of Haryana and various other pronouncements and settled principles of law as detailed in the writ petition. Further prayed to promote the petitioner to the post of Head Master High School w.e.f. 15.03.2021 and promotion order dated 15.03.2021 (Annexure P-8) may kindly be stayed.

The said instant writ petition came up for hearing before the Hon'ble High Court on 20.03.2023. The operative part of the order passed by the Hon'ble High Court is as under:-

*\*\*\*\*\*Notice of motion.*

*On the asking of this Court, Mr. RS Budhwar, Additional AG Haryana, accepts notice on behalf of the respondents-State and submits that he has no objection if the aforesaid limited prayer made by the learned counsel for the petitioner is allowed.*

*In view of the above and without commenting anything on the merits of the case, the petitioner would be at liberty to move a representation for redressal of his grievances, within two weeks from today, if so advised.*

*On his doing so, respondent No.2-Director Elementary Education, Haryana, is directed to decide the said representation, within a period of eight weeks thereafter, by passing a speaking order, as per law.*


*Disposed of in the above terms."*

In view of order dated 20.03.2023, it is stated here that the Hon'ble High Court had granted liberty to the petitioner i.e. Sh. Ravinder Singh (hereinafter called as claimant/representationist) to move a representation w.r.t. redressal for his grievance within 2 weeks from the date of the decision i.e. 20.03.2023. It is relevant to mention here that the claimant/representationist has not submitted any representation to this directorate today. However, after perusal of writ petition, relevant record and MIS profile

of the claimant, it has been found that the claimant was initially appointed as TGT Social Studies vide appointment order No. 2/37-93 E II (I) dated 22.02.1994. Thereafter, he was promoted to the post of Elementary School Headmaster vide order No. 15/66-2010-HRM-II (1) dated 27.05.2014 and as per the MIS profile of the claimant, it is clear that he was promoted to the post of PGT Political Science from the post of TGT Social Studies vide order No. 15/13-2017 PGT-II (3) dated 24.04.2017 by Directorate of Secondary Education and joined the same in Government Girls Senior Secondary School Gohana Mandi (3559), District Sonipat. Moreover, the claimant is claiming for promotion to the post of High School Headmaster from the post of TGT Social Studies which has to be considered by Directorate of Secondary Education being the competent authority as per provision of Haryana State Education School Cadre (Group-B) Service Rules, 2012. It is relevant to mention here that the claimant had not arrayed the Directorate of Secondary Education which is a necessary party in the present writ petition to decide the claim of the claimant.

Keeping in view the facts available on record, as no representation has been moved by the claimant/representationist as per order of Hon'ble Court on 20.03.2023, the establishment of the Directorate of Secondary Education is the competent authority to decide the claim raised by the claimant in the writ petition. Hence, the claim of the claimant is not tenable as same cannot be decided by the undersigned and hereby rejected in above terms.


