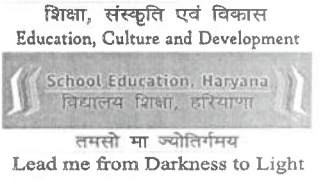

In case it transpires at a later stage that he is ineligible for the above promotion, the department would be competent to revert the concerned official to his original post without any notice.
