



Order No. 14/09-2019 D&L (1)

Whereas a FIR No. 334 dated 17.09.2018 was lodged against at Police Station Ladwa, District Kurukshetra against Sh. Bikram Singh (030305), ESHM, GMS Barhan, District Kurukshetra under Section 323 of IPC, 1860 and Section 12,14 & 15 of POCSO Act, 2012. Consequently, the charged official was placed under suspension w.e.f. 18.09.2018 vide order dated 18.09.2018. In the meanwhile, the Ld. Court of Additional Sessions Judge (Exclusive Court for Heinous Crime against Women), Kurukshetra vide its judgment dated 10.12.2018 acquitted Sh. Bikram Singh of all the charges leveled against him. The District Attorney, Kurukshetra vide its letter dated 06.05.2019 intimated that no appeal was preferred against the judgment dated 10.12.2018. Subsequently, the charged official was issued charge sheet under Rule-7 of Haryana Civil Services (Punishment and Appeal) Rules, 2016 vide order dated 06.09.2019. Thereafter, Sh. Bikram Singh was reinstated pending inquiry in services vide order no. 14/09-2019 HRM-III (2) dated 17.09.2019. Sh. Bikram Singh submitted his reply to the charge-sheet on 18.10.2019 and vide order dated 15.01.2020, Sh. Balwan Singh, IAS (Retd.) was appointed as inquiry officer to conduct the regular departmental inquiry.

Thereafter, on 07.08.2020, the inquiry officer submitted its inquiry report with conclusion that there was no credible evidence to prove the charges against Sh. Vikran Singh, therefore, the charges are not prove against Sh. Bikram Singh. Resultantly, the charge-sheet under Rule-7 issued against Sh. Bikram Singh was dropped by the then Additional Director Admn. vide order dated 30.10.2020 after taking into the consideration the factual matrix of the case. Thereafter, the charged official made a representation dated 19.11.2020 regarding to condone the suspension period (18.09.2018 to 17.09.2019) as well as to count the suspension period in service period and again made a representation dated 08.02.2023 for the same in the light of Ld. Trial Court judgment dated 10.12.2018 and the inquiry report dated 07.08.2020. Accordingly, the charged official was provided the opportunity of personal hearing on 04.09.2023 by the undersigned wherein he was heard at length.

Whereas, after examining all the facts of the case, the judgment dated 10.12.2018 passed by the Ld. Court of Additional Sessions Judge (Exclusive Court for Heinous Crime against Women), Kurukshetra, the inquiry report dated 07.08.2020 and the

representation dated 08.02.2023 made by the charged official, it is found that the charged official has been acquitted by the Ld. Court vide its judgment dated 10.12.2018 and also as per the inquiry report dated 07.08.2020 submitted by the inquiry officer after conducting regular departmental inquiry, the charges were not proved against Sh. Bikram Singh.

Hence, in the light of above facts and in the light of Rule-87 read with Rule-90 of HCS (General) Rules, 2016, the suspension period (18.09.2018 to 17.09.2019) of Sh. Bikram Singh, ESHM, GMS Barhan, District Kurukshetra presently posted at GMS, Dhanora Jattan, District Kurukshetra is hereby treated as duty period for all intent and purposes.

Ordered accordingly.
