Terms and conditions:-

1. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
2. He/She shall have to take an oath of allegiance to the Constitution of India.
3. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
4. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
5. He/She shall be on probation for a period of one year. The period of probation can be extended for a period not exceeding one year, if considered necessary.
6. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules-2016 as applicable to

be got verified within stipulated period. This relaxation does not confer any right to a candidate to remain in job, if subsequently anything adverse is reported against him/her at later stage as mentioned in Governemnt Instruction No. 52/08/2022-3GS-III dated 23.06.2022.
