In pursuance of instructions of Chief Secretary, Haryana issued vide letter No. 22/10/2013-1GS-III dated 17/19.04.2017 & 22/10/2013-1GS-III dated 25.03.2022 & 22/59/2020-1GS-III dated 01.07.2022 amended from time to time and on recommendations of State Commissioner for the Persons with Disabilities, Department of Social Justice and Empowerment, Haryana in case No. 392/2021 titled Bansi Lal Jhorar Vs. Additional Chief Secretary School Education and Another, the following Physically Challenged teachers are hereby granted promotion as per details mentioned against their names, in the pay scale notified under Haryana Civil Services (Pay) Rules applicable at that particular time under 4% reservation in PwD quota with benefit of notional pay fixation although such TGTs will not be entitled for any arrears till the date of this order.

2. These promotion order are subject to review/cancellation in case of any discrepancy regarding eligibility detected at any stage.
3. That these promotion orders are subject to without prejudice to the right of senior physically challenged if any whose promotion cases may be decided at a later stage.
4. That these promotions are subject to the condition that no adverse remarks found in the integrity of the ACRs.
5. That their seniority in Master Cadre in PwD Quota will be determined as per instructions/ rule issued from time to time by Government of Haryana/ Department.
6. The employee should fulfil his eligibility criteria of educational qualification and disability certificate as per service rule in case of it transpires at any stage he is ineligible



for the promotion and he will be reverted to their previous original post without any previous notice.

7. The benefit of reservation in promotion to the employees with disability is only entitled from the date of submission of his medical certificate of disability to the department in accordance with chief secretary Haryana instruction clarification number 22/202/2017-2 GSIII issued on dated 1 January 2018.
8. They are directed to provide latest disability certificate/UDID issued on Swavlambancard.gov.in portal within 30 days failing which, they will be reverted back without giving any notice.

Whereas Sh. Kanwar Singh alias Balwant Singh, S.S. Master was suspended vide order dated 12.02.2001 due to his involvement in issuance of fake transfer orders and he was charge sheeted under Rule 7. During pendency of inquiry, Sh. Kanwar Singh alias Balwant Singh, S.S. Master (under suspension) prepared a fake orders of lecturer in English and manipulated with fake documents posing his transfer order from GSSS Jhandsa (Gurgaon) to GGSSS Yamuna Nagar vide order dated 28.08.2001 and joined in the same school on 27.09.2001. Thereafter, again Sh. Kanwar Singh, S.S. Master (suspended) prepared his fake orders of transfer to the post of lecturer to GGSSS Sabji Mandi (Yamuna Nagar) but in fact, he was S.S. Master at that time. Lastly, he himself prepared a fake order of transfer and joined GSSS Laha (Ambala).

Accordingly, an F.I.R. No. 12 of 29.01.2004 under section 166/167/419/420/467/468/471/477/477-A and 120-B IPC was registered against 12 accused relating to School Education Department. Subsequently, Sh. R. C. Sharma, HCS (retired) was appointed as Inquiry Officer to conduct a regular inquiry in the present matter. The inquiry officer submitted his inquiry report on 13.06.2012. Sh. Kanwar Singh alias Balwant Singh was convicted with imprisonment for a period of 2 years by Hon'ble Court of Sub-Divisional Judicial Magistrate (SDJM) at Naraingarh vide order dated 31.03.2012. Consequently, on the basis of conviction of Sh. Kanwar Singh by Hon'ble Court of Sub-Divisional Judicial Magistrate (SDJM) at Naraingarh this office dismissed him from service vide its dismissal order dated

12.06.2012. Thereafter, Sh. Kanwar Singh preferred a criminal appeal No. 172 of 2012 against the judgment and order dated 31.03.2012 passed by the Hon'ble Court of SDJM in the Court of Amarjit Singh, Additional Sessions Judge, Ambala. The Learned Court of Additional Sessions Judge, Ambala vide its order and judgment dated 31.01.2013 acquitted Sh. Kanwar Singh of the charges framed against him and set aside the judgment and order dated 31.03.2012 passed by the Ld. Trial Court. Afterwards, Sh. Kanwar Singh made representation dated 07.04.2014 and 08.06.2020 to reinstate him services in the light of the judgment and order dated 31.01.2013 passed by the Learned Court of Additional Sessions Judge, Ambala. Accordingly, the matter was taken into consideration in view of the representation made by Sh. Kanwar Singh and accordingly, the undersigned being appointing authority-cum competent authority provided the opportunity of personal hearing to Sh. Kanwar Singh on 06.11.2023.

After examining the facts of the case, it came into the notice of the undersigned that the Ld. Appellate Court of District and Sessions Judge, Ambala has acquitted Sh. Kanwar Singh vide its order and judgment dated 31.03.2013 and as per the official record available on the file, no appeal or review pending against order dated 31.03.2013. It also came into notice that a separate file has been perused in which 9 other convicted employees had been reinstated on the basis of judgment, but the decision about Sh. Kanwar Singh is nowhere discussed on that file or in the present file. Sh. Kanwar Singh was dismissed from services solely on the basis of conviction passed by SDJM, Naraingarh (Ambala) and since this order of conviction has already been set aside and Sh. Kanwar Singh has been acquitted from all the charges framed against him and his counterparts have already been

reinstated in services, therefore Sh. Kanwar Singh also deserves to be reinstated in services as he has been acquitted by the Appellate Court vide judgment dated 31.01.2013 under the principle of Natural Justice.

Hence, in the light of above cited facts, the judgment and order dated 31.01.2013 passed by the Ld. Court of Additional Sessions Judge, Ambala and the representations made by Sh. Kanwar Singh, the undersigned being appointing authority-cum-competent authority hereby ordered that Sh. Kanwar Singh, TGT Social Studies (Dismissed), GHS Darouli, District Rewari is reinstated in services conditionally without any prejudice to departmental disciplinary action and accordingly, be posted in GMS Gothari (3803) District Narnaul against vacancy of TGT Social Studies.
