4. If any adjustment have been done by concerned DEO/DEEO at district due to any reason that will be nullified w.e.f order date.
5. The TGTs of Mewat cadre are allowed to join the schools located in Nuh (Mewat) district only.
6. Selected TGT (Physical Education)/Master (DPE) should be relieved only after the completion of current academic session.
7. Superintendent of concerned TGT branches are directed to update the orders on One School App/MIS.

**Note:** The concerned employees, before joining the new station of posting, shall be liable for updating the court orders/vacating the stay within 10 days from date of issuance of this order.
