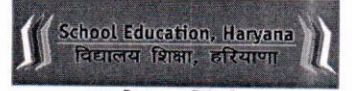

**ORDER**

**Order No. 17/531-2023 TGT Estt. (2)    Dated, Panchkula, the 07.02.2024**

Whereas, Sh. Pervez Hussain S/o Sarfuddin, and Sh. Anwar Khan S/o Sh. Chahat Khan approached the Hon'ble High Court by way of filing a Civil Writ Petition No. 16692 of 2023 titled as "Pervez Hussain and another Vs. State of Haryana & others" inter-alia praying therein for directing the respondents to consider the petitioners under Mewat Cadre by considering the service rendered by the petitioners as qualifying service in rest of Haryana cadre in view the fact that Respondent No. 3 (DEEO, Mewat) sent the cases of 13 teachers including the petitioners whereas 11 out of 13 teachers were included in the final seniority list dated 01.06.2020 but later on it was withdrawn by the authority for the purpose of changing the cadre from Rest of Haryana Cadre to Mewat Cadre in pursuance of letter dated 20.10.2020. The above writ petition was came up for hearing before the Hon'ble High Court on dated 09.01.2023 and the Hon'ble Court pleased to dispose of the same with following directions:-

*"Notice of motion.*

*4. Mr. Sanjeev Kaushik Additional Advocate General, Haryana appearing on advance notice, submits that the pending representation, 20.04.2023, shall be decided by the respondent No.2 expeditiously.*

*5. In view thereof, without going into the merits of the case, the instant petition is disposed of with a direction to respondent No.2 to consider and decide the pending representation, dated 20.04.2023, by passing a speaking order in accordance with law, within a period of six weeks from the date of receiving a certified copy of this order."*

In compliance of above mentioned direction, both the Representationist/Petitioners were provided opportunity of personal hearing vide letter no. 17/531-2023 TGT R&A (2) dated 01.02.2024. They were heard at length on 05.02.2024 and their cases have been considered by taking into consideration all facts and circumstances to change their cadre from Rest of Haryana to Mewat Cadre.



Hence, keeping in view of the facts of the present case and acute shortage of teachers in mewat cadre, It is decided to change their cadre permanently subject to condition mentioned below and they are directed to join at the place of posting with immediate effect as mentioned below:-

**Terms and conditions:-**

1. Teacher going from Rest of Haryana Cadre to Mewat Cadre permanently will have to lose the seniority of Haryana Cadre and seniority will be given to Mewat Cadre from the extreme end and they will have to submit affidavit to loose the seniority of their previous cadre at the time of joining.

I pass the present order in compliance of order dated 09.01.2023 passed in CWP No. 16692 of 2023 titled as "Pervez Hussain and another Vs. State of Haryana & others".
