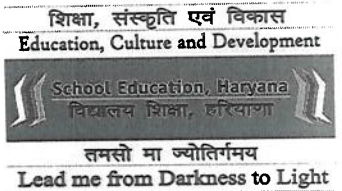

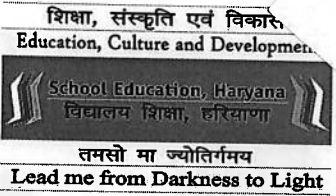

The above promotions subject to the following terms and conditions:-
