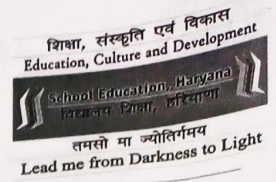

6. That the posting order of the promoted teacher will be issued later on, separately.



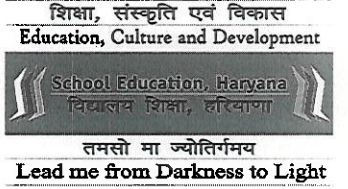


